

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION REGULAR MEETING
September 22, 2016**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, September 22, 2016, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda and discuss the Commission Tour of Facilities.

The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, September 22, 2016, in the Grover W. Taylor Council Chambers 8353 Sierra Avenue, Fontana, Fontana, California. The meeting was called to order at 7:02 p.m. by Chairperson Espinoza, followed by an Invocation given by Pastor Daniel Vasquez, Calvary Chapel of Fontana and the Pledge of Allegiance led by Commissioner Coleman.

SPECIAL PRESENTATION:

- A. INTRODUCTION OF NEW COMMUNITY SERVICES DEPARTMENT STAFF**
Parks and Community Services Manager Aaron Orozco welcomed new Parks and Community Services staff to introduce themselves.

Community Services Coordinator David Arrendondo introduced himself and shared his history of working with the City of Fontana for eight years. He will be overseeing projects at Don Day Neighborhood Center.

Community Services Coordinator Guadalupe Johannsen introduced herself and shared that she had 15 years of community service experience.

Community Services Coordinator Nicholas Stark introduced himself and shared that he started with the City of Fontana in 2009 as a lifeguard at Fontana Aquatics Park and will now oversees the day to day operations of the Jessie Turner Health and Fitness Center.

B. SPECIAL RECOGNITION

Aaron Orozco introduced Community Services Supervisor Karen Gerber to introduce the staff at the Jessie Turner Health and Fitness Center that worked during the Blue Cut Fire Emergency Evacuation.

Karen Gerber, Community Services Supervisor introduced Doug Johnson, Christina Enriquez, Estella Ontiveros, Cecilia Benavides, Yukiko Springer; Cynthia Morales to be recognized by the Parks and Community Services Commission for their efforts at the Jesse Turner Neighborhood Center Team during the Blue Cut Fire Emergency Evacuation.

Chairperson Espinoza also recognized Karen Gerber for her efforts.

C. SENIOR CENTER MONTH

Community Services Supervisor Tiffany Starks introduced Senior Advisory Board Chair Kathy Potts and Member at Large Betty Sandoval to speak on the City of Fontana Proclamation recognizing September as National Senior Month.

Kathy Potts spoke on the different events and programs at the Senior Center.

Betty Sandoval spoke on getting to know people, always having someone to talk to, and all of the seniors at the Fontana Community Senior Center having fun. She never went to her senior prom, and she was selected as the 2016 Senior Queen.

PUBLIC COMMUNICATION:

Darlene Scalf spoke on changing the date of the Fontana Days celebration to earlier in the year when there is not the extreme heat of June and schools are in session. According to photos she has seen, Fontana Days has been held in April 25, 1987; May 22, 1976; and April 19, 1986, in past year. She feels thousands more would come if it was held earlier. The Exchange Club is in charge of this and has heard that they are not interested. The carnival after the parade is in a park and the City has to approve the use. She also spoke on not having a park in the poorest part of town near the following schools: Oleander, Date, Citrus, Poplar, Truman, Fohi, Jurupa Hills, and Citrus. There are 38

parks in the city, and not a single park near those areas. She listened to the reverend this evening speak on parks being a safe place to go, the kids in this area do not have a safe place to go. Poplar Elementary School kids have to go five miles to go to a park; the majority of people in that area are of color and wonders if they are being discriminated against. For the \$6 million being spent at Miller Park, two great parks could have been put in that area.

Kathy Potts spoke on the Community Parking Lot Sale at 16710 Ceres Avenue, Fontana, California 92335, on Saturday, October 22, 2016, from 8:00 a.m. to 2:00 p.m. Interested vendors that sold at the last parking lot sale have priority registration on October 14, from 3:00 p.m. to 6:00 p.m. and October 15, 2016, from 8:00 a.m. to 12:00 p.m.; new vendor registration is on October 17-21, 2016, from 9:00 a.m. to 12:00 p.m. and 3:00 p.m. to 6:00 p.m. Cost is \$20 for one stall and \$30 for two stalls. Betty Sandoval shared the information in Spanish. The stalls will not have power.

Councilmember Jesse Sandoval recognized the Fontana Community Senior Center Prom Queens.

Councilmember Jesse Sandoval presented a \$170 check for the Dr. Koehler Veteran's Day Essay Contest. He has personally donated the funds for the awards since he was a Parks and Recreation Commissioner in 1999. The Veteran's Day Essay was established because there was no child participation in the Veteran's Day Ceremony.

Fran Givens, spoke on today being National Centenarian Day. She shared a story about a gentleman sharing a home with his mother and mother-in-law.

C. CULTURAL ARTS 2015-2016 FISCAL YEAR UPDATE - KRISTY SAMPLES

Community Services Supervisor Kirsty Samples introduced Community Services Coordinator Ana Casillas who introduced Senior Community Services Assistant Jeanette Hernandez to assist in providing Cultural Arts Fiscal Year Update.

The majority of cultural arts programming is held at Art Depot Gallery, Steelworkers' Auditorium and Center Stage Theater; with programming at additional facilities throughout the City serving 84,464 community members.

The Fontana Arts Summer Camp was expanded this year to begin earlier and adding field trips.

The Youth Community Theater Program was expanded by offering two productions.

Pajama Paint Night Workshops and DIY Make and Create Workshops were new this year.

The Gallery Exhibition and Showcase featured four artists this year and each artist provided free workshops.

Family Art Night Events, Recital Performances and Teen Talent Show were offered at the Steelworkers' Auditorium.

Noche Con Ritmo Salsa Nights, Murder Mysteries and Musicals were offered at Center Stage Theater.

The Fontana Arts Festival had a flash mob, living statues, and live speed painting; there were 54 participating artists and 6,500 points of contact.

The Art Depot Gallery, Steelworkers' Auditorium, and Center Stage Theater are available for rent. There were over 180 rentals and 8,000 points of contact.

Partnerships with organizations include the Fontana Arts Association and offered ceramics classes through Koehler Gallery. There were over 29,000 points of contacts through partnerships.

Feedback from surveys indicate that 44% learned key components of creativity and 48% learned key components of education; also 80% would like see more of this type of programming and 77% saw the Fontana Arts as a valuable community resource.

Everyone is invited to celebrate National Arts and Humanities Month in October by participating in upcoming events, including DIY Make & Create Foil Pumpkins and Dia De Los Muertes Celebration.

Youth Community Theater will have a Peter Pan Jr. production on November 11 and 12, 2016. Tickets are \$12 and available at Center Stage Theater.

Manager Wright encouraged all citizens 55 and older to visit the Fontana Community Senior Center located at 16710 Ceres Avenue, or call 909.854.5151.


Manager Wright spoke on the Let's Move on the Trail Event on October 8, 2016. There will be 84 health or safety related vendors participating.
