The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, April 26, 2012, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, Fontana Days Parade participation, Park Tour Schedule to be held on May 5, 2012, Commission reorganization, and Co-Sponsorship Process Overview. ## **Presentations**

### **PACIFIC ELECTRIC TRAIL UPDATE**

Community Services Supervisor Rob Bock and Administrative Analyst Monique Molina presented on the Big Play Day on the Pacific Electric Trail. The official grand opening of the City of Fontana's portion of the Pacific Electric Trail will take place on May 12, 2012, between Baseline and Cherry. There will be activities for children and families, with opportunities for eligible participants to receive a promotional item from Wendy's, Graziano's and Blockbuster that day. All attendees will also receive a commemorative water bottle of the event.

Administrative Analyst Molina shared a map of the Pacific Electric Trail from the LA County Line to Rialto, California, and provided the history of the Pacific Electric Trail that is complete from Los Angeles County to Fontana. Some of the benefits of the trail include a commuter route to public transportation, healthy alternative to driving, safe connection to schools and public facilities, and use by the Fontana Walk and Bike Club Route.

**NEW BUSINESS:**

A. **CIP Update-Lynn Rogers**

Senior Accountant, Lynn Rogers, is responsible for coordinating the City's Annual Capital Improvement Program (CIP) and presenting the 2012-13 Open Space and Recreation Category to the Parks and Community Services Commission for review and discussion; and to obtain the Parks and Community Services Commission's determination that the Preliminary CIP is in conformance with the Open Space and Recreation Element of the General Plan.

The CIP includes projects that involve the purchase or construction of major fixed assets, generally those costing more than \$10,000. The City is required to adopt a CIP per State Government Code 66000, Assembly Bill 80-1600. The formal CIP must include a minimum of a five-year expenditure plan; the City's CIP is in a seven-year format. Funding for projects comes from discretionary and non-discretionary funds. Discretionary funds can be used for a project anywhere in the city. Non-discretionary funds can only be used for projects that meet certain specific criteria.

The CIP is consistent with City Council goals, which include practicing sound fiscal management, promote economic development, investing in the City's infrastructure, and promote affordable housing.

This is the City of Fontana's 22nd CIP, which builds on last year's award winning document which received the Excellence in Capital Budgeting Award. The CIP is prepared with input from the public and each of the City's departments; the Management Services Department compiles the CIP and it will be presented to the City Council on June 18, 2012 for adoption during a public hearing.

Projects are classified based on project priorities one through four. There are three Priority 1 projects, Central Park, Miller Park Amphitheater, and Sports Park. These projects are considered essential and should be started within one year; however, due to loss of Redevelopment Funds, these projects remain on hold. There are seven Priority 2 projects that should be started between one and three years. There are no Priority 3 projects. There are three Priority 4 projects scheduled to start within five to 10 years. The total open space and recreation project costs are \$61.7 million. No additional funding is being requested for any projects.

Commissioner Vaquera asked if there were any foreseen sources of funding. Public Works Manager Dan West replied that there are no other sources currently available. Director Nelson added that funding sources are always being sought via grants, etc.

A motion was made by Commissioner Vaquera and seconded by Commissioner Espinoza to determine that the CIP is consistent with the Open Space and Recreation Element of the General Plan. Motion carried unanimously.

**B. Co-Sponsorships for FY 2012-2013-Rob Bock**

Community Services Supervisor Rob Bock provided a review of co-sponsorship requests received from various organizations for Fiscal Year July 1, 2012, through June 30, 2013.

Sixteen organizations submitted applications for co-sponsorship this year during the February application period. A total of 16 eligible applications were received with two requesting the use of facilities while the remaining 14 requested co-sponsorship assistance with community events.

The recommended co-sponsorship funding for this fiscal year is \$37,458. Funding for co-sponsorships in the amount of \$37,500 was included in the Community Services proposed 2012-2013 fiscal year budget request, leaving a balance of \$42 for the September 2012 application period.

A motion was made by Commissioner Vaquera and seconded by Commissioner Quiroga to approve staff's recommendation and move this item forward to the City Council on Tuesday, June 12, 2012, for consideration and approval. Motion carried unanimously.

**C. Summer Day Camps – Karen Gerber**

Community Services Coordinator Karen Gerber reported on the Summer Day Camps being offered throughout the City for the warm summer months of June, July and August to inspire, enrich, and stimulate the youth of Fontana.

A new online registration system is being implemented this year to accommodate the long lines and wait times that were previously experienced. Registration is also still available at neighborhood Community Centers.

Affordable Summer Day Camps offered this year include:

The Fontana Arts Summer Camp creates opportunities to experience personal inspiration, artistic expression, and develop an appreciation for the arts.

The Recreation Day Camps provides activities that are designed to create a positive exciting environment encourage self confidence and promote physical health and activity, while assisting in implementing fitness, nutrition, and safety.

The Sports Camp offers campers a fun filled interactive approach to being physically active and also benefit by building social skills, positive relationships with all fellow campers and confidence in their athletic abilities.

The Nature Discovery Camp offers hands-on activities in science, outdoor investigation, and group games. The Nature Center's features create a safe, healthy outdoor environment, with the goal of expanding the experiential horizon of participants.

Teens are offered a camp designed specifically for them and pre-teens that include daily activities such as Wii, Xbox, Kinect Tournaments, arts and crafts and team sports.

In partnership with the Fontana Unified School District, free nutritious lunches and healthy afternoon snacks will be provided to all summer camp participants through the United States Department of Agriculture Summer Feeding Program.

The goal of the Summer Day Camps is to make a safe, fun and unique environment that will foster self-confidence, personal expression, and respect for others.

**D. Aquatic Season Preview Summer 2012 – Megan Wolfe**

Community Services Coordinators Megan Wolfe and Christina Enriquez reported on the Aquatic Summer Season 2012.

Aquatics programs will be offered at Don Day Neighborhood pool, Heritage Pool Complex, Miller Fitness Center pool, Fontana Park Aquatic Center, and opening in late summer 2012, the Martin Tudor.

Recreational swim begins May 6, 2012, at the four pool sites.

The Fontana Park Aquatic Center will be open Monday through Friday 12:00 to 4:00 p.m.; Saturday and Sunday from 12:00 p.m. to 5:00 p.m.; and Monday through Saturday from 7:00 p.m. to 9:00 p.m. Fees are \$3 for children or \$5 with the slide and \$5 for adults or \$7 with the slide. Monthly passes are available for \$35.

The community pools will be open Monday through Friday from 1:00 p.m. to 5:00 p.m.; Saturday and Sunday from 12:00 p.m. to 5:00 p.m.; and Tuesday through Saturday from 7:00 p.m. to 9:00 p.m. Fees are \$1.50 for children and \$3 for adults. A family pass is available for \$160 for a family of four with \$40 for each additional family member and can be used at all the community pools.

Pool parties will be held on Friday nights at Heritage Pool Complex. Fees are \$1.50 for children and \$3 for adults. A family pass is available for \$160 for a family of four with \$40 for each additional family member and can be used at all the community pools.

Swim lessons will be offered at all pool sites. Fees are \$45 per session, which is Monday through Friday for two weeks.

Lap Swim is available at Fontana Park Aquatic Center, Monday through Friday, from 5:30 a.m. to 7:30 a.m. and 10:00 a.m. to 2:00 p.m. and on Saturday from 7:00 a.m. to 9:00 a.m. and; at Miller Fitness Center, Monday through Friday from 11:00 a.m. to 1:00 p.m.



Aqua Aerobics is available at Fontana Park Aquatic Center, Monday through Thursday, from 7:00 a.m. to 8:00 a.m. and from 6:30 p.m. to 7:30 p.m. and Monday through Saturday, from 9:00 a.m. to 10:00 a.m.; at Miller Fitness Center Monday through Thursday from 9:00 a.m. to 10:00 a.m. and from 6:15 p.m. to 7:00 p.m. for seniors only; and at Heritage Pool Complex Monday through Thursday, from 9:00 a.m. to 10:00 a.m.

Specialty programs include the Fontana Aquatics Club, Fontana Tiger Sharks and Jr. Lifeguard program.

Upcoming events include Aqua Prom on May 12, 2012, from 6:00 p.m. to 10:00 p.m. is open to high school students at Fontana Park Aquatic Center; and the Martin Tudor Splash Park Grand Opening in late summer 2012.

Commissioner Quiroga asked if the season pass will be valid at Martin Tudor once it is opened. Staff replied that it would be.

Commissioner Espinoza asked what the cost was for the Jr. Lifeguard Program and if it was only offered at Fontana Park Aquatic Center. Staff replied that it is \$100 for a four week session and is only available at Fontana Park Aquatic Center.

Commissioner Vaquera asked what the dress code was for Aqua Prom. Staff replied that it varies from formal prom dresses to swimsuits, but attendees cannot go into the pool with their clothes on.

**E. Athletic Field Allocation Overview – Rafael Gonzalez and Hector Vasquez**

Community Services Coordinators Hector Vasquez provided a report on the Athletic Field Allocation. Over 20 resident organizations ranging from youth organizations to adult leagues. There are 59 athletic fields allocated to use for soccer, football, baseball, and softball with 153 permits in service per month.

Twice per year, an Athletic Field Allocation Meeting is held with user groups to discuss field permits, rentals, fees, policies, procedures, applications and residency requirements. Meetings are mandatory to be considered for the upcoming allocation period. The next meeting will be held on Wednesday, May 9, 2012, at 6:00 p.m. at the Jessie Turner Health and Fitness Center.

Commissioner Vaquera stated that the meeting is open for any Parks and Community Services Commissioners to attend.

**F. Fontana Community Senior Center Third Quarter Update – Michael Wright**

Community Services Supervisor Michael Wright introduced Community Services Coordinators Leslie Ramirez, Virginia Solis and Tiffany Starks to assist in presenting the Fontana Community Senior Center Third Quarter Update.

The Fontana Community Senior Center has been opened for almost two years. There were 1,704 members at the end of last year, with current membership at 1,574, well over the expected membership when the facility was opened.

The Fontana Community Senior Center experienced an increase in all of its programs. There are 39 clubs offered with 25,040 participants. Classes provide an opportunity for 55+ aged members to keep active, meet new people, and be social. Themed dances offered throughout the year are scheduled the second Friday of each month. Staff has coordinated 8 dances with 673 participants. The fitness room has provided 16,938 participants with the opportunity to work out, improve their health, and enhance their quality of life. Nine special events have been held, including "Nightmare on Ceres", "Holidays in Candyland", "Luck of the Irish", and had a total of 1,820 participants. There are 43 classes offered including dance, foreign language, aerobics in espanol, absolute abs, pilates yoga, Zumba, basket weaving, computer, aprenda ingles and conversational Spanish, with 2,581 participants in one or more classes. Classes are added throughout the year to meet the demand of the community and to keep up with trends. There have been 9 excursions to various locations including the Autry Museum, Santa Barbara, LA County Fair, Huntington Library, Old Town Pasadena, San Juan Capistrano, The Queen Mary and the next one is the Santa Barbara Tram. Participation numbers are remaining steady.

Lunch service is offered Monday through Friday; from 11:00 a.m. to 1:00 p.m. Seniors can enjoy a meal with family and friends as well as meet new people. A total of 36,469 meals have been served with an average of 198 per day. More meals have been served this fiscal year than last fiscal year. The chefs ensure that the meals are nutritious and post the nutrition information for seniors. In December, 400 meal tickets were sold for the holiday feast. The goal of the senior center is to provide a healthy well-balanced meal at an affordable cost. Seniors rate the meals and the highest score has been "a zillion stars"!

Transportation services offered include a demand response program that operates Monday through Friday, 8:00 a.m. to 5:00 p.m. and Saturdays, 8:00 a.m. to 12:00 p.m. Curbside to curbside services provide transportation to business in Fontana. Beginning Monday, April 30, 2012, transportation services are being expanded to include a senior apartment complex shuttle. The cost for a transportation pass is \$25 for one round trip per day or \$1 per one way trip. There have been 169 total annual van passes sold and 31,700 one way trips have been provided. The Transportation program seeks to provide services that impact the community.

The Fontana Community Senior Center Resources center offers presentations, workshops, and consultations on senior related issues and concerns. Services are offered Monday through Friday from 8:00 a.m. to 3:00 p.m. Seniors can receive information on legal assistance, health insurance planning, health screenings and many more services. The Resource Center partners with 53 organizations to provide these services to seniors. Services provided include flu shots, tax assistance, and safety, health and wellness, and health screenings. Approximately, 4,091 individuals have been assisted through the Resource Center, and attendance has been consistent.

Rentals are available at the Fontana Community Senior Center. The Courtyard can be used for a wedding, to take pictures, or host a baby shower. The assembly rooms are also available. Rentals have increased 13% from last year, with 198 rentals and average of 16 per month and many returning renters.

The Fontana Community Senior Center Advisory Board is the latest addition to the senior services. It is a group of like minded seniors who serve as the eye and ears for the senior community. In November 2011, Board members were elected serve on the Board. The Board has established a list of goals, created subcommittees. The Board helps to strengthen the communication between the Senior Center Staff and the patrons.

The community was invited to visit the center or the website.

Commissioner Goñi commended the Fontana Community Senior Center staff.

Commissioner Goñi commented that she is aware of families coming from Ontario.

Commissioner Espinoza asked if lunch was on a walk in basis. Staff replied that it is open to everyone and only 200 meals are served per day.

Commissioner Vaquera stated that his parents visited from Mexico last year and they enjoyed it.

Staff stated that vegetarian meals are also offered.

Commissioner Vaquera confirmed that the \$25 pass was for one round trip per day. Staff added that the shuttle is available for multiple stops.

Commissioner Vaquera stated that he appreciates the value given to senior citizens.

Chairperson Rowland commended the food as she has eaten there.

**G. Special Events Update – Rob Bock**

Community Services Supervisor Rob Bock provided a special events update for the month of March as follows:

- The Miss Fontana Pageant was held on March 17, 2012, at Steelworkers' Auditorium with a record 46 contestants. Kristal Eshleman was named Miss Fontana, Melissa Au was named Senior Princess, and Ellyse Martinez was named Junior Princess. This event was cosponsored by the Rotary Club with the City providing facilities, equipment, and staffing.
- The first Fontana Car Show was held at City Hall on March 31, 2012, from 3:00 p.m. to 5:00 p.m. with 30 cars and 100 participants. This is a non-cruising event and will be held the last Saturday of the month from March to October. *Guilty Conscience* performed and this event was sponsored by America's Tire Company.

Community Services Supervisor Rob Bock also provided a report on upcoming events for the month of May:

- Fontana Car Show will be held on May 26, 2012, at City Hall, from 3:00 p.m. to 5:00 p.m. There will be a live band and food vendors. This event is sponsored by America's Tire Company and the City of Fontana.
- 99<sup>th</sup> Annual Fontana Days festival will be held at Veteran's Park from Thursday, May 31 to Sunday, June 3, 2012. The gates open on May 31 at 5:00 p.m. to 10:00 p.m., on June 1, from 5:00 p.m. to 11:00 p.m., on June 2, from 12:00 p.m.



to 11:00 p.m, and on June 3, from 12:00 p.m. to 10:00 p.m. There will be carnival rides, food vendors, live entertainment, and a car show. There will be a parade on Saturday, June 2, at 11:00 a.m. on Sierra Avenue from Arrow to Merrill. This event is sponsored by the Exchange Club and the City of Fontana.

City Clerk Lewis clarified that there will not be a car show at this year's Fontana Day's Event, but next year they are inviting 100 cars, one from each year, to participate.


Chairperson Rowland thanked the Commission for the learning experience serving as Chair.
