

**CITY OF FONTANA  
PARKS AND COMMUNITY SERVICES COMMISSION  
REGULAR MEETING  
NOVEMBER 29, 2012**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, November 29, 2012, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, discuss 2013-2014 Program/Service Goals, get a User Fees update, and discuss Commission Appointments. #### **NEW BUSINESS**

##### **A. Jack Bulik Teen Center Update – Jason Hendrix**

Community Services Supervisor Jason Hendrix provided an update on the Jack Bulik Teen Center.

The Jack Bulik Teen Center enjoyed a tremendous 2012 Summer. As a part of our annual teen camp program, approximately 400 youth spent their summer at the Jack Bulik Teen Center. Campers had an opportunity to participate in daily group activities, including scavenger hunts, sports tournaments, and healthy eating activities. Each Wednesday, participants had the option to visit several attractions in Southern California, such as Hangar 18 rock climbing, the USS Midway tour, and the most popular excursion; Six Flags Magic Mountain. Over 300 teens participated in the 2012 summer Excursion Series.

On September 29, 2012, the Jack Bulik Teen Center, in partnership with the Fontana After School Program, Healthy Fontana, and the Boys & Girls Club of Fontana, held the Second Annual Families Play Together Event. The Families Play Together Event featured STEM (Science, Technology, Engineering, and Math) activities that allow participants to discover the math and science behind everyday occurrences. Activities included building your own rocket to “blast”, slime racers, blender bikes where you make your own salsa or smoothie, and make your own box racer. Entertainment for the day was provided local alternative rock band, Violent Son. Each participant that completed every STEM activity received a free meal provided at a discounted rate by local restaurant, Juan Pollo. The event was well received by the community with approximately 350 Fontana families in attendance.

October is always a frightfully good time at the Jack Bulik Teen Center. The annual Knott's Scary Farm Excursion took place on Saturday, October 6, 2012. Forty-two participants survived the expanded mazes and monsters prowling throughout the amusement park grounds. On Saturday, October 28, 2012, staff along with the assistance of eighteen volunteers began construction of this year's haunted house named “Fear Factories”.

In the latest installment in the Jack Bulik Teen Center annual Haunted House, there were five elaborate and frightening rooms, three alley ways and a minimum of fourteen “monsters” patrolling the house during the hours of operation. The event was widely promoted on the City of Fontana's Facebook page allowing teens and adults alike to “share” the event details resulting in a total of 595 Fontana residents who “survived” this year's haunted house.

The Teen Talent Show was held in collaboration with the Cultural Arts Division. There were 36 participants performing beat boxing, a cappella, individual instruments, and group shuffle dances. Members of the Mayor's Youth Advisory Council served as event judges with Olivia Kiefer, 8<sup>th</sup> grade student at Truman Middle School the grand prize winner.

When not involved in holiday and community events, the Jack Bulik Teen Center provided daily activities that continue to evolve in order to best meet the needs of today's youth. Teen Center staff has put together several clubs that members have asked for and responded to by alerting their friends about the place to be for Fontana Teens.

The Triple H Club (Homework Help Hour) gives participants an opportunity to use the computer lab or ask for staff assistance to complete homework and major school projects. The Teen Sports Club promotes physical activity and wellness by highlighting three major sports (basketball, baseball and football) as teens compete against one another. Members celebrate by watching a professional game on the new LCD flat screen television. The Teen Fitness Club continues to be a popular destination for hopeful athletes looking for a place to train in preparation for school tryouts. Staff closely monitors participants and tailors workout programs to meet their individual needs. The Teen Center is home to approximately 25-30 participants daily from 2:00 p.m. to 7:00 p.m.

The Jack Bulik Teen Center is looking forward to providing its members with even more innovative and exciting programming in the coming months. Partnerships with Leading Edge Learning Centers, Reach Out, the Fontana Community Coalition (FCC), Community Alliance for Fontana Students (CAFFS), and Children's Resources, promises to give members the opportunity to enrich their lives each time they visit the Teen Center.

Commissioner Quiroga commended the fantastic job being done at the Jack Bulik Teen Center.

Vice Chairperson Vaquera asked if applications are being accepted to become members of the MYAC. Supervisor Hendrix replied that applications are now being accepted at the Jack Bulik Teen Center from 2:00 to 7:00 p.m.

Vice Chairperson Vaquera commended Supervisor Hendrix on the great job.

Commissioner Espinoza asked for an update on the MYAC Thanksgiving event. Supervisor Hendrix replied that the MYAC members held a food drive and delivered the boxes of food donated to eight families; the boxes included everything needed for a perfect Thanksgiving meal.

#### **B. Special Events Update – Bianca Morales**

Community Services Coordinator Bianca Morales provided a special events update for events held in October:

- Saturday, October 6, 2012, the Mayor's Jazz Jam, was held at the Fontana Community Senior Center from 6:00 p.m. to 11:00 p.m. Two hundred fifty people were in attendance to dance the night away to the Reggie Vision Band and enjoy food from Spaggi's. The event and silent auction helped raise over fifty-four thousand dollars for the Fontana Boys and Girls Club.

- Saturday, October 27, 2012, the Fontana Car Show, the final one of the season was held in the City Hall parking lot from 3:00 to 5:00 p.m. with thirty cars. Over 100 residents came out and viewed the classic cars while children in costumes participated in Trunk or Treating. Live music was provided by Outstanding and a free slice of pizza was provided by My New York Pizza to all car owners participating in the Trunk or Treating.
- Wednesday, October 31, 2012, the Cypress Neighborhood Center Halloween Event held its Cypress Monster Bash with a circus show theme and was open to the community free of charge. The event consisted of a pumpkin patch with free pumpkins and a decorating area, a magic show with a professional magician, a fortune teller, and a petting zoo with pony rides, a circus character display show with each character in a themed room, a costume contest and a trunk-or-treat in the parking lot, provided by the Water of Life Church. Five hundred residents came to celebrate at the Cypress Neighborhood Center.
- Wednesday, October 31, 2012, the Don Day Neighborhood Center Halloween Event allowed families to enjoy a fun and safe Halloween at Southridge Park. The event was full of families enjoying games, crafts, jumpers, balloon animals and the costume contest. Residents were able to experience the snakes from the Mary Vagle Nature Center. Costume contests were held for children from ages 0 to 17 years of age. Rio Ranch Market provided a booth with fun games and treats as well. Eight hundred people came out to this successful event.
- Wednesday, October 31, 2012, the Jessie Turner Health and Fitness Center held its Halloween Spooktacular "Trunk or Treat" and it was a big success with nearly 3,000 community members participating. This year's "Spooktacular" event was held in the front parking lot and participants were invited to enjoy trunk-or-treating which included 19 vehicles decorated with great Halloween décor. Various game booths, arts and crafts, face painting and costume contest for all ages as well as a group theme category were enjoyed. There was a picture booth by "Smiles are Contagious" where families could pay a small fee to have their pictures taken with a festival back drop. Participants were able to enjoy roving entertainment which included a magician and balloon artist by Magic and Variety.
- Sunday, October 28, 2012, through Wednesday, October 31, 2012, the Jack Bulik Teen Center staff along with eighteen volunteers, constructed this year's haunted house, "Fear Factories". In the latest installment in the Jack Bulik Teen Center annual Haunted House, there were five elaborate and frightening rooms, three alley ways and a minimum of fourteen "monsters" patrolling the house during the hours of operation. Five hundred ninety-five people "survived" this year's haunted house.

Commissioner Vaquera acknowledged Planning Commissioner Hall's attendance at tonight's meeting.


Commissioner Vaquera asked to keep in prayer those less fortunate than us.
