

**MINUTES OF THE CITY OF FONTANA

**CALL TO ORDER:**

**A. Strategic Plan for the Fontana Fire Protection District**

A staff presentation was provided by Fire Chief James Johnstone and new Fire Chief Jon McLinn.

Commissioner Tahan stated that with the approved Strategic Plan for the Fontana Fire Protection District that response times would improve.

Fire Chief Johnstone stated that response times would improve from Fire Station

73 that served the Village of Heritage, and response times would improve from Fire Station 77 that served south Fontana.

Commissioner Tahan inquired about the annual fire inspection program.

Fire Chief Johnstone stated that a formal presentation will be made at an October Fire District meeting regarding a fire enhancement program.

City Manager Hunt stated that this item will be brought back in October for a formal presentation of the fire enhancement program. Mr. Hunt stated that the implementation of the Strategic Plan will begin in Fiscal Year 15/16, which included the fire enhancement program.

There were no other Elected Officials Communications/Reports received.




