

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
MARCH 20, 2014**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, March 20, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda. Chairperson Quiroga and Commissioners Coleman, Espinoza, Goñi, Rowland, Tigner and Vaquera were present.

The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, February 27, 2014, in the Grover W. Taylor Council Chambers, 8353 Sierra Avenue, Fontana, California. NEWBUSINESS

A. Special Events Update-Michael Wright

Community Services Supervisor Michael Wright introduced Community Services Assistant Lauren Griffen to provide an oral update on special events held in the month of February, which included the Stand Up Speak up Youth Job Fair; Black History Parade; Jazz N' Art Celebration; and upcoming events in April which included the Fontana Car Show on April 4, 2014; Special Olympics on April 5, 2014; and the CAP (Community Assistance Program) Resource Fair on April 24, 2014, at the Jessie Turner Health and Fitness Center.

B. Cultural Arts Fiscal Year 2012-2013 Update – Michael Wright

Community Services Supervisor Michael Wright introduced Community Services Coordinator Courtney Hodnick and Community Services Coordinator Nathan Hunt to provide an update on the Cultural Arts Fiscal Year 2012-2013.

Coordinator Hodnick spoke on visual arts which include the art galleries in the city; programming; community outreach, Learning Educational Arts Program (L.E.A.P); and the Fontana Art Association partnership.

Coordinator Hunt spoke on the Steelworkers' Auditorium performances; Center Stage Theater which offers musicals, cabarets, murder mysteries, dancing showcases, concerts, special events, and rentals; and special engagements such as the Fontana Arts Festival.

Coordinator Hunt thanked the Parks and Community Services Commissioners for their participation in events.

Commissioner Goni commended everything that is done through the galleries and the performance and asked about volunteer opportunities. Information is available at the community centers.

Chairperson Quiroga spoke on the wonderful job staff does in providing the citizens of Fontana with good quality arts.

C. Nature Center Update – Michael Wright

Community Services Supervisor Michael Wright introduced Community Services Coordinator Rick Dean to provide an update on the Nature Center.

Community Services Coordinator Rick Dean spoke on the revitalization of the Nature Center and a recently published article naming the Mary Vagle Nature Center as one of "30 Fun Spring Break Activities For Under \$35".

Coordinator Dean provided information on the focus for the 2013 work plan, programs offered at the Nature Center, the youth leadership program; partnerships with Inland Empire Resource Conservation District, California Regional Environmental Education Community (CREEC), Hands on Inland Empire (United Way), Santa Ana Watershed Association, and California Conservation Corps; and Signature Events such as Arbor Day on April 17, 2014, and National Public Lands Day on September 27, 2014.

Commissioner Goni commended staff on the development of the Mary Vagle Nature Center over the years.

City Clerk Lewis personally thanked Rick Dean for all of his support on the Rose Garden.

Commissioner Coleman spoke on going to the Mary Vagle Nature Center years ago when it was not so nice and it is now a beautiful facility.

Chairperson Quiroga spoke on the treasure the Mary Vagle Nature Center is to the City of Fontana.

Director Nelson spoke on Coordinator Dean's amazing work at the Mary Vagle Nature Center.

D. 2014 Easter Events - Garth W. Nelson

Community Services Director Garth W. Nelson introduced Community Services Supervisor Karen Gerber to provide a report on the 2014 Easter Events.

Supervisor Gerber spoke on the Easter Events being held on April 19, 2014, at three sites in Fontana – Don Day Center will have a pancake breakfast, egg hunts, jumpers, and games; Cypress Center will have a pancake breakfast, egg hunt, crafts,

and games; Jessie Turner Center will have an egg hunt, class demonstrations, games, and jumpers.

Discussion was held on any activities will be held for children with special needs. All children are invited to participate in all of the events.

E. 2014 Summer Day Camps - Garth W. Nelson

Community Services Director Garth W. Nelson introduced Community Services Supervisor Karen Gerber to provide a report on the 2014 Summer Day Camps.

Supervisor Gerber spoke on the 2014 Fontana Summer Camps in the City of Fontana. There are seven camps, including Nature Discovery Camp at Mary Vagle Nature Center; TEAM (Teens Engaged and Motivated) Camp at Jack Bulik Teen Center; Fontana Arts Summer Camp at the Art Depot; Camp Imagination at Cypress Neighborhood Center; Camp JED (Journey Explore and Discovery) at Heritage Neighborhood Center; Sports Summer Camp through the Sports Division; Camp FIT at Jessie Turner Health and Fitness Center.

Online registration begins on April 5 and runs through April 18; walk in registrations begin on May 3, 2014.

Discussion was held on the cost of meals; they are free.

Discussion was held on the youngest age of the camp participants, must be 5 years old and completed Kindergarten and some camps are offered to the age of 18.

Supervisor Wright announced that Senior Prom tickets go on sale Monday, March 24, 2014 for \$3 for dance and \$4 for dinner!


Supervisor Wright announced the art exhibit that opens on April 8 and runs through May 23, 2014.

PUBLIC WORKS COMMENTS:


