

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
FEBRUARY 27, 2014**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, February 27, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, discuss the Employee of the Year Selection; and review the Commission Program and Service Goals. The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, February 27, 2014, in the Grover W. The meeting was called to order at 7:06 p.m. by Chairperson Vaquera, followed by an Invocation given The Gathering of the Inland Empire, Pastor Mark Rogers, and the Pledge of Allegiance led by Commissioner Vaquera.

NEW BUSINESS

PUBLIC WORKS COMMENTS:




Chairperson Vaquera wished everyone a good night.
