

**CITY OF FONTANA  
PARKS AND COMMUNITY SERVICES COMMISSION  
SPECIAL MEETING  
MAY 8, 2014**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 5:30 p.m. on Thursday, May 8, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda and review Co-Sponsorship applications. Chairperson Quiroga and Commissioners Coleman, Espinoza, Goñi, Rowland, and Tigner were present.

The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, May 8, 2014, in the Grover W. Taylor Council Chambers, 8353 Sierra Avenue, Fontana, California. The meeting was called to order at 7:13 p.m. by Chairperson Quiroga, followed by an Invocation given by Commissioner Goni, and the Pledge of Allegiance led by Commissioner Tigner.

**SPECIAL PRESENTATION:**

**A. Special Recognition - Community Services Manager - Frances Hernandez**

The Parks and Community Services Commission recognized Community Services Manager Frances Hernandez for her years of service to the City of Fontana.

Director Nelson announced that Manager Hernandez will be recognized at the City Council meeting on Tuesday, May 13, 2014.

Director Nelson invited everyone to a reception to honor Manager Hernandez on May 14, 2014, 3:00 to 5:00 p.m. at City Hall.

**PUBLIC COMMUNICATION:**

Terry Boykin spoke on the success of the Million Father March and thanked the City for their support last year; and planning to return to Fontana. This year's event has incorporated Fathers Against Neglect, Abuse and Sex Trafficking. Mr. Boykin shared printed information.

Danny Marquez, Veteran's Resource Center, spoke on his passion for connecting resources for veterans. He thanked City staff for all the help and support that is given to his organization. He spoke on the San Bernardino Give Big Campaign that began this morning at 7:00 a.m. and ends at 7:00 a.m. tomorrow morning. All donations remain in the Inland Empire. There are five Fontana organizations listed in the campaign, including the Fontana Historical Society, Boys and Girls Club, Industrial Support System, and Veteran's Partnering With Communities; he asked for everyone to make donations.

**NEW BUSINESS**

**A. Co-Sponsorships For Fiscal Year 2014-2015**

Director Nelson thanked the Parks and Community Services Commissioners for their work on the co-sponsorship applications; this is an important process to help create community.

Community Services Director Garth Nelson introduced Community Services Coordinator Rob Bock to provide a report on the Co-Sponsorships for Fiscal Year 2014-2015.

Commissioner Goni indicated that she participated in the prioritization of the Co-Sponsorship applications.

Commissioner Goni excused herself from the meeting at 7:40 p.m. due to an emergency.

Chairperson Quiroga noted that Commissioners Espinoza and Vaquera, who are absent tonight, also participated in the prioritization of the Co-Sponsorship applications.

Director Nelson introduced Community Services Supervisor Michael Wright to review the consensus of prioritization.

Supervisor Wright indicated that a total of 16 applications were fully or partially funded for a total of \$37,500. The following applications were not funded: Fundacion de Empesarios Latino Americanos, Mexican Independence Day Parade and Concerned Citizens for the Development of North Fontana, Health Fair; and the

following applications were partially funded: Veterans Partnering with Communities, Thank a Hero Honor a Hero and Concerned Citizens for the Development of North Fontana, Black History Parade.

**ACTION:** Motion was made by Commissioner Rowland, seconded by Commissioner Tigner, and passed unanimously by a vote of 4-0 to provide a recommendation on the Co-Sponsorships for Fiscal Year 2014-2015 and forward it to the City Council for consideration.

Supervisor Wright congratulated his son, Richard, for being selected as student of the month.


Commissioner Coleman congratulated Supervisor Wright on his son.
