

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
MAY 22, 2014**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, May 22, 2014, in the Executive Conference Room at Fontana City Hall, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, preview the Summer Programming and obtain a Public Works Facility update. Parks and Landscape Supervisor Erik Garwick announced that thanks to technology Public Works is capable of removing graffiti within 24 hours.


ADJOURNMENT:
