

**MINUTES OF THE CITY OF FONTANA  
REGULAR PLANNING COMMISSION MEETING  
July 01, 2014

**CALL TO ORDER/ROLL CALL:**

**A. 6:00 P.M. Call to Order/Roll Call**

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, July 1, 2014, in the Grover W. Taylor Council Chambers, 8353 Sierra Avenue, Fontana, California. Chairperson Cothran called the meeting to order at 6:00 p.m.

**INVOCATION/PLEDGE OF ALLEGIANCE:**

**A. Invocation/Pledge of Allegiance**

Following the Invocation given by Vice-Chairperson Slowik, the Pledge of Allegiance was led by Secretary Armendarez.

**A. Public Communications**

**CONSENT CALENDAR:**

**A. Approval of Minutes**

Approve the Planning Commission Minutes of May 20, 2014, June 3, 2014, and the Planning Commission Minutes of June 23, 2014.

A motion was made by Commissioner Slowik and seconded by

Commissioner Meyer to approve the minutes of the May 20, 2014, Planning Commission Meeting. Motion passed by a vote of 5-0.

A motion was made by Commissioner Meyer and seconded by Commissioner Armendarez to approve the minutes of the June 3, 2014, Planning Commission Meeting with corrections provided by Commissioner Meyer. Motion passed by a vote of 4-0-1 with Commissioner Slowik abstaining.

A motion was made by Commissioner Meyer and seconded by Commissioner Garcia to approve the minutes of the June 23, 2014, Special Planning Commission Meeting. Motion passed by a vote of 5-0.

## **PUBLIC HEARINGS:**

### **A. Master Case No. 13-063, Administrative Site Plan No. 13-037**

Staff recommends that the Planning Commission continue this item to the July 15, 2014 Planning Commission meeting. Project Planner, Jon S. Dille, Assistant Planner.

Planner Dille provided an update on the work being done with the Applicant on the project.

Attorney Gomer recommended this item not be discussed if it is to be continued.

A memo on buildings and covered structures will be attached to the report for the Planning Commission's information.

Commissioner Meyer noted that he will not be here for the July 15, 2014, Planning Commission meeting and asked that this item be continued to the first meeting in August.

**ACTION:** Motion was made by Secretary Armendarez and seconded by Commissioner Garcia to continue this item to the August 5, 2014, Planning Commission meeting. Motion passed by a vote of 5-0.

### **B. Master Case No. 13-027, Design Review Project No. 14-003**

Project Planner, Jon S. Dille, Assistant Planner, provided the staff report.

Discussion was held on the letter received at the dais in opposition to this project. The letter was entered into the record.

Discussion was held on the landscaping of the project.

Discussion was held on the street connecting to the North Woods Community

once the right of way is acquired by the applicant.

The Public Hearing was opened.

Speaking for the applicant, Ryan Combe, thanked staff for their work.

Applicant agreed to all conditions of approval and mitigation measures.

Discussion was held on the 2,800 sq. ft. plan having a full bathroom downstairs.

Discussion was held on the size of the garage.

Discussion was held on adding designs to deter conversion of living spaces into bedrooms.

Discussion was held on the look of the rear of the property that faces a busy street.

Applicant stated that this development is nicer than any homes they have had approved before, but is open to any suggestions.

Commissioner Meyer suggested adding a condition for enhanced consistency that is agreeable to the Director of Community Development.

Discussion was held on the solar panels.

Commissioner Garcia suggested looking at City policy in order to have consistency and have it understood by everyone.

The Public Hearing was closed.

**ACTION:** Motion was made by Commissioner Meyer and seconded by Secretary Armendarez to 1) Direct staff to file the Notice of Determination that relies on a previously approved CEQA document; and, 2) Approve Design Review Project No. 14-003 with a condition for Project Developer to work with Community Development Director.

Discussion was held on the additional standards being recommended. Commissioner Slowik is opposed to doing it on a project by project basis.

Commissioner Meyer suggested a standard additional condition until the standard is set. Commissioner Meyer withdrew the motion.

The Public Hearing was reopened.

The applicant proposed adding shutters on the homes visible from the public

right of way.

The Public Hearing was closed.

**ACTION:** Motion was made by Commissioner Meyer and seconded by Secretary Armendarez to 1) Direct staff to file the Notice of Determination that relies on a previously approved CEQA document; and, 2) Approve Design Review Project No. 14-003, with a condition added for the Project Developer to work with Community Development Director to add a condition for enhanced consistency on the sides and back of those houses that are on street corners. Motion passed by a vote of 4-1 with Vice-Chairperson Slowik opposing.

## **DIRECTOR COMMUNICATIONS:**

### **A. Director Communications**

The Planning Commission reviewed an update of future City Council Agenda items for the July 8, 2014, and July 22, 2014, meetings for the Planning Commission's information; and an update of future Planning Commission items for the July 15, 2014, July 22, 2014 (Workshop) and August 5, 2014, meetings for the Planning Commission's information.

Director Troyer wished everyone a happy 4th of July.

## **COMMISSION COMMENTS:**

Commissioner Garcia wished everyone a safe 4th of July.


