The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, August 28, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, review Commissioner Assignments, Volunteer Recognition Event and User Fees. City Clerk Lewis thanked Erick Garwick for all his work on the Rose Garden.


City Clerk Lewis announced that her granddaughter, Molly, is graduating from Air Force boot camp.
