

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
NOVEMBER 20, 2014
6:00 PM**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, November 20, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, review user fees and co-sponsorships. Supervisor Erick Garwick wished everyone a happy evening and a Happy Thanksgiving.


Commissioner Goñi spoke on the use of Access Fontana.
