

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
DECEMBER 11, 2014
6:00 PM**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, December 11, 2014, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, a Field Management Program Update, and a workshop on Access Fontana. The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, December 11, 2014, in the Grover W. - A. Teen Programs Update - Aaron Orozco**
Community Services Manager Aaron Orozco introduced Community Services Coordinator Jessica Gandara and Community Services Coordinator Jason Hendrix to provide an update on Teen Programs.

The Community Services Department provides a wide-range of teen focused activities, programs, and events with the goal of creating city-wide opportunities for all teens. Teen services are currently available at the Jack Bulik Teen Center, Jessie Turner Health & Fitness Community Center, Heritage Neighborhood Center, and the Don Day Neighborhood Center.

- B. Healthy Fontana Annual Update - Michael Wright**
Community Services Manager Michael Wright introduced Community Services Coordinator Dee Dee Benson to provide an annual update on Healthy Fontana.

The Community Services Department continues to integrate the Healthy Fontana message throughout all programming, services and events the department offers.

In 2014, Healthy Fontana has outreached to over 93,400 people to educate or provide resources to the community. These outreach efforts include education within the Fontana After School Program, 55+ events and the weekly Farmers' Market. All of these are possible by being awarded over \$470,000 in grants in the past 6 years and over 22 partnerships developed to enhance or provide services.

The City of Fontana is ranked number one in the Nation for the *Let's Move Cities, Towns and Counties* initiative and was the first City in California to reach five gold medals for this initiative. The Mayor and City Council were presented with an award for the City's accomplishments at the National Congress of Cities Conference in Austin, Texas in November.

There will be two Farmer's Markets in the City.

Manager Wright spoke on the outdoor fitness equipment on the Pacific Electric Trail being ADA accessible.

C. Access Fontana - Erik Garwick

Landscape Supervisor Erick Garwick walked through how to report an issue using the Access Fontana application program available for all residents to use.

Access Fontana is an application that is designed to report issues in your community with easy to use mobile and web applications. Access Fontana can be accessed by visiting www.Fontana.org or by downloading the application to your iPhone or android smart phone through the app store or goggle play.

Supervisor Garwick wished everyone a merry Christmas and a happy new year.


ADJOURNMENT:
