

**MINUTES OF THE CITY OF FONTANA
REGULAR PLANNING COMMISSION MEETING
July 07, 2015

CALL TO ORDER/ROLL CALL:

A. 6:00 P.M. Call to Order/Roll Call

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, July 7, 2015, in the Grover W. Taylor Council Chambers, 8353 Sierra Avenue, Fontana, California. Chairperson Cothran called the meeting to order at 6:05 p.m.

CONSENT CALENDAR:

A. Approval of Minutes

Approve the Planning Commission Minutes of June 16, 2015.

A motion was made by Vice Chairperson Meyer and seconded by Commissioner Rowland to approve the minutes of the June 16, 2015,

Planning Commission Meeting. Motion passed by a vote of 5-0 with corrections provided by Vice Chairperson Meyer.

PUBLIC HEARINGS:

- A. Master Case No. 15-029, Conditional Use Permit No. 00-028R1, modify operating hours of an existing commercial vehicle repair facility. Request to continue item to the August 18, 2015 Planning Commission Meeting.**

The Public Hearing was opened.

No member of the audience spoke in favor or opposition to the project.

ACTION: Motion was made by Secretary Garcia and seconded by Commissioner Quiroga to continue this item to the August 18, 2015, Planning Commission meeting. Motion passed by a vote of 5-0.

- B. Master Case No. 15-019, Tentative Tract Map No. 19944, a request to subdivide four (4) parcels of approximately 2.2 acres into 10 single-family residential lots.**

DiTanyon Johnson, Associate Planner provided the staff report.

The Public Hearing was opened.

A Design Review will be submitted for the Planning Commission's approval.

Speaking for the applicant, Shareef Awad, spoke on the size of the lots and the one and two-story homes.

David Tomlin spoke in favor of the project.

The Public Hearing was closed.

ACTION: Motion was made by Vice Chairperson Meyer and seconded by Secretary Garcia to 1) Determine that the project is Categorically Exempt pursuant to Section No. 15332, Class No. 32 (Infill Development), of the California Environmental Quality Act; and 2) Approve Tentative Tract Map No. 19944. Motion passed by a vote of 5-0.

Discussion was held regarding the appeal for MCN#15-046/APL#15-01 on the July 21, 2015, Planning Commission agenda. The Planning Commission requested definition on the matter for the appeal, which is the appeal of the Director of Community Development denial of an electric fence.

Chairperson Cothran had a grand time spending the 4th of July with his family.


Chairperson Cothran announced a workshop on the Westgate Specific Plan being held at Heritage Neighborhood Center on July 8, 2015.
