

**CITY OF FONTANA  
PARKS AND COMMUNITY SERVICES COMMISSION  
REGULAR MEETING  
FEBRUARY 26, 2015  
6:00 PM**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, February 26, 2015, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda. Secretary Espinoza, Commissioners Goñi, Rowland, Tigner and Vaquera were present.

The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, February 26, 2015, in the Grover W. Taylor Council Chambers, 8353 Sierra Avenue, Fontana, California. The meeting was called to order at 7:10 p.m. by Interim-Chairperson Espinoza, followed by an Invocation given by Pastor Arthur Adams and the Pledge of Allegiance led by Commissioner.
