

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION REGULAR MEETING
March 24, 2016**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, March 24, 2016, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, discuss the Commission Oath of Office, Commission Reorganization and a CIP overview.

NEW BUSINESS:

A. Special Events 2016 Calendar Review – Rob Bock

Community Services Supervisor Rob Bock provided a report on special events conducted in January and February 2016:

- January 15, 2016, Martin Luther King Celebration; The New Ephesians Testament Church hosted this co-sponsorship event at the Steelworkers’ Auditorium to celebrate the birthday of civil rights leader Martin Luther King Jr. This event was a jazz themed event that featured Makeda Francisco – former lead singer of Rose

Royce, saxophonist Jeanette Harris, and jazz guitarist Ray Fuller. Two hundred and twenty community members supported the celebration.

- February 27, 2016, Black History Parade; The Concerned Citizens for the Development of North Fontana and the City of Fontana collaborated on presenting the Black History Month Parade and Expo co-sponsorship event. Over one hundred fifty spectators came out to enjoy the parade which had 22 entries from Fontana and the surrounding region. The parade proceeded south on Citrus from Summit to Sierra Lakes Parkway.

Community Services Supervisor Rob Bock provided a review of upcoming events as follows:

- April 1, 2016, Fontana Car Show, 5:00 p.m. to 9:00 p.m. at City Hall. The band Road Dogs will perform.
- April 21, 2016, Community Assistance Program Resource Fair, 12:00 p.m. to 4:00 p.m. at Jessie Turner Health & Fitness Center. There will be over 100 resource vendors available for the community.

B. 2016 Aquatics Summer Preview - Geneo Farrar:

Community Services Supervisor Geneo Farrar and Pool Manager Teresa M. Ramirez provided a 2016 Aquatics Summer Preview.

There are five Fontana Aquatic facilities include three community pools; Don Day Pool, Heritage Pool, and Miller Pool. Recreation Swim will be offered at all five aquatics facilities beginning May 28, 2016, through August 7, 2016, including the Fontana Park Aquatic Center. Additionally, Martin Tudor Splash Park will be open.

- Don Day Pool, Heritage Pool and Miller Pool will be open Monday through Friday from 1:00 p.m. to 5:00 p.m.; Saturday and Sunday from 12:00 p.m. to 5:00 p.m.; and Tuesday through Saturday from 7:00 p.m. to 9:00 p.m. Cost is \$3.00 for adults; \$2.00 for children; \$1.50 seniors (55+ years old) and children under 2 years old are free.
- Fontana Park Aquatic Center will be open Monday through Sunday from 12:00 p.m. to 5:00 p.m. Cost is \$5.00 for adults; \$3.00 for children; \$1.50 for seniors (55+ years old) and children under 2 years old are free. Use of the water slide is available for an additional \$2 per person.
- Martin Tudor Splash Park will be open Monday through Friday from 11:00 a.m. to 5:00 p.m.; Saturday and Sunday from 11:00 a.m. to 5:00 p.m. Cost is \$5.00 for adults; \$3.00 for children; \$1.50 for seniors (55+ years old); and children under 2 years old are free.

All recreational swim facilities will be open Memorial Day Weekend, 4th of July, and Labor Day Weekend from 12:00 p.m. to 5:00 p.m. Registration for Session One of Swim Lessons begins on Saturday, April 30, 2016, with lessons beginning Tuesday, May 31, 2016. Registration is available by walk-in at all community centers or at aquatics.fontana.org.

Classes are held Monday through Friday, 30 minutes each day, for two weeks and are available to residents of any skill level and of all ages. Semi-private, private and parent and me lessons are also available. Cost is \$45 for lessons; \$65 for semi-private; and \$100 for private lessons (an additional \$12 for non-residents).

Saturday morning and teen (12-18) and adult swim lessons are also available. A Swim Lesson Special Event "Swim to Win Swim Meet" is a pool versus pool meet held on Sunday, July 17, 2016, at 8:00 a.m. at the Fontana Park Aquatic Center.

Family fun summer events will be held this summer as follows:

- Family Fun Nights at Miller Pool, Heritage Pool, and Don Day Pool each Tuesday night from June 7 through July 26, 2016, from 7:00 p.m. to 9:00 p.m.
- Dive-In Movie Night at Heritage Pool every Friday night from June 10 through July 29, 2016, from 7:00 p.m. to 10:00 p.m.
- Dive-In Movie Re-Runs at Don Day Neighborhood Pool every Saturday night from June 11 through July 30, 2016, from 7:00 p.m. to 10:00 p.m.

Cost for each of the family fun summer events is \$3.00 for adults; \$2.00 for children, and \$1.50 for seniors 55+ years old.

Teen special events will be held this summer as follows:

- SPF6.11 (Summer Party Factor) at Heritage Pool, June 11, 2016, from 6:00 p.m. to 10:00 p.m.
- Midsummer Madness at Martin Tudor Splash Park, July 9, 2016, from 6:00 p.m. to 10:00 p.m.

Cost is \$2.00 for teens between 12 and 17 years old with a valid Middle School or High School Photo ID.

Aquatic Fitness Classes are available at Don Day Pool, Miller Pool and Fontana Park Aquatic Center. Aqua Aerobics and Lap Swimming are available. Cost is \$3.00 per day and \$2.00 for seniors; or \$35 per month and \$20 per month for seniors.

The Fontana Parks Aquatic Center also has Water Polo, Jr. Lifeguard Training, and Adult and Child Competitive Swim Teams.

The Junior Lifeguard Program is offered at Fontana Park Aquatic Center and Don Day Pool.

The Community Services Department is looking forward to another successful year of summer aquatic programming with something for every age and ability.

Private Pool Rentals are available at all pool sites on Saturdays and Sundays around the recreational swim schedule.

C. 2016 Summer Camp Preview – Karen Gerber

Community Services Supervisor Karen Gerber provided a preview of the 2016 Summer Camp programs.

There are nine camps being offered this summer as follows:

- Camp Southridge will operate four two-week sessions June 6 thru July 29, 2016, from 9:00 a.m. to 5:00 p.m. at Don Day Neighborhood Center for children 5 to 12 years old. Campers will enjoy fun-filled daily activities that include cooperative games, arts & crafts, team building, fitness, sports, science, and swimming.
- Teen Camp will operate eight one-week sessions June 6 thru July 29, 2016, from 9:00 a.m. to 6:00 p.m. at Don Day Neighborhood Center for 12 to 15 year olds. Campers will have adventurous and unique experiences with excursions held twice a week. Teens will also have the opportunity to participate in weekly activities that include team competitions, art, music, and swimming.
- Nature Discovery Camp will offer four one-week sessions July 5 through July 29, 2016, at Mary Vagle Nature Center for youth ages 6-11. This camp offers an opportunity for participants to try new outdoor experiences and meet new friends.
- Summer Arts Camp will offer eight one-week sessions June 6 through July 29, 2016, from 8:00 a.m. to 6:00 p.m. at the Art Depot and Steelworkers' Auditorium for youth ages 7-11. This camp offers participants a chance to explore the arts and learn a whole host of techniques.
- Camp Imagination will offer four two-week sessions June 6 through July 29, 2016, at the Cypress Neighborhood Center for children ages 5-12 years old. This camp offers arts & crafts, team competitions, outdoor and indoor interactive games, science experiments, talent shows, and more. This camp offers an array of activities that will include interactive games, cheers, competitions, arts & crafts, team building activities, science experiments, talent shows, and swimming.
- Sports Camp will offer eight one-week sessions weekdays from 9:00 a.m. to 5:00 p.m. at Fontana Park for youth ages 5-12. Participants embark on an adventure as they are exposed to a variety of sports, games, and crafts, weekly swim visits at the Fontana Park Aquatic Center
- Jr. Lifeguard Camp is a 4-week camp, held Monday through Thursday from 8:00 a.m. to 12:00 p.m. at Don Day Pool and Fontana Park Aquatic Park for those interested in becoming a lifeguard to gain knowledge and skills that will help them in their future.
- Camp Fit will offer four two-week sessions June 6 through July 29, 2016, at the Jessie Turner Health & Fitness Community Center. Campers will have the opportunity to take part in the following activities daily: arts & crafts, team competitions, outdoor and indoor interactive games, and science experiments.

The 2016 Summer Food Program is a collaboration between the Fontana Unified

School District and the City of Fontana. This program allows each Summer Camp to offer an additional service to the participants who are enrolled. Each day more than 500 Camp participants throughout the City will receive a nutritious lunch and snack at no additional cost. All meals meet and exceed the State of California SB-12 School Nutrition Standards.

Fontana residents can register online beginning Saturday, April 2, 2016, at 6:00 a.m. and in person at community centers beginning Saturday, May 7, 2016. Non-residents can register beginning May 14, 2016.

Director Nelson spoke on the expansion of some of the summer camp programs.

Supervisor Gerber spoke on the camps filling up quickly and encouraged everyone to plan to register early.

Chairperson Espinoza welcomed Fontana Unified School District Board Member Mary Sandoval and City Council Member Jesse Sandoval to the meeting.

D. Mayor's Youth Advisory Council - Teen Leadership Summit - Jamie Bumia

Community Services Supervisor Jamie Bumia introduced Community Services Coordinator Felix Bobo to provide the Mayor's Youth Advisory Council update.

Coordinator Bobo thanked Supervisor Bumia, Community Services Manager Aaron Orozco, and Director Nelson for the opportunity to work with an awesome group of teens.

The MYAC kicked off the year attending the UCLA Special Olympics World Games in August 2015 to support the athletes competing. MYAC members attended the Friday Night Live Traffic and Safety Summit in Anaheim, California and learned techniques on how to promote safe driving. Through a collaboration with Lala's Hearts and Rainbows and Eat Well Be Well during Thanksgiving week, MYAC members assisted with feeding needy families in San Bernardino County.

The 2016 Teen Leadership Summit was held on February 20, 2016. MYAC members worked with City of Fontana staff to coordinate the summit at AB Miller HS to empower local teens. Vendor participants included local colleges, Healthy Fontana, Art Depot, REACH OUT, We-Tip, Friday Night Live, Community Alliance for Fontana Students (CAFFS), Fontana Police Department Explorers, Fontana Community Coalition, Successful Women in Motion, The American Lung Association and the Big Brothers and Big Sisters of America.

MYAC members continue to be a valuable asset to the community. The professionalism exhibited thus far has been impressive, with each member contributing to the overall group. Determination, leadership, teamwork, communication, creativity, and innovation will guide the Mayor's Youth Advisory Council to many great accomplishments that are sure to impact the Fontana community for many years to come.

Commissioner Bravo commended staff on the invaluable service that they provide and for always going above and beyond.

Chairperson Espinoza also commended staff for all of their work.

E. Mary Vagle Nature Center Update - Rick Dean

Community Services Coordinator Rick Dean provided an update on the Mary Vagle Nature Center.

Over the past few years, there have been a number of projects completed, both exterior and interior at the Mary Vagle Nature Center. These projects have been completed in collaboration Public Works and Community Services.

The quality nature center includes quality educational programming.

Saved money because the redesign was done in-house.

One of the huge programs is the environmental education programs for regional schools.

Landscaping is focused on California native water-wise plants.

The pond is an ongoing challenge.

Commissioner Coleman spoke on the sophistication of the facility.

Commissioner Bravo commended Rick on presenting with a passion for what he does.

Chairperson Espinoza spoke on a wedding at the Nature Center.

Supervisor Farrar spoke on the Mobile Fresh Fruit Bus at the Fontana Community Senior


Center on March 29, 2016; at the Pacific Electric Trail at Seville on April 5, 2016; and Oak Park Elementary School on March 30, 2016.
