

**CITY OF FONTANA**  
**PARKS AND COMMUNITY SERVICES COMMISSION REGULAR MEETING**  
**April 28, 2016**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, April 28, 2016, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, discuss the Annual Commission Reorganization, review Co-Sponsorships, discuss Fontana Days Parade Involvement, and review the Parks and Community Services Commission 3-month calendar.

**B. CIP Review - Lynn Rogers**

Resource Budget Officer Lynn Rogers provided a report on the Capital Improvement Program and recommended that the Parks and Community Services Commission review and approve the Fiscal Year 2016/2017-2022/2023 Seven-Year Capital Improvement Program Preliminary Budget and Determination of Consistency with the General Plan's "Open Spaces and Recreation Element".

Discussion was held on funding of projects.

Discussion was held on the development plans for the Miller Amphitheater and the lighting renovation at Ralph M. Lewis.

Discussion was held on the amphitheater design.

**ACTION:** Motion was made by Commissioner Rowland, seconded by Commissioner Coleman, and passed by a vote of 5-0 to approve the Fiscal Year 2016/2017-2022/2023 Seven-Year Capital Improvement Program Preliminary Budget and

Determination of Consistency with the General Plan's "Open Spaces and Recreation Element".

**A. Special Events Update – Rob Bock**

Community Services Supervisor Rob Bock was absent; Community Services Manager Jennifer Hunt provided a report on special events conducted in March 2016:

- March 4, 2016, Fontana Car Show. There were 300 residents, 68 classic, custom, low riders, and muscle cars. The band Chico provided music, children enjoyed the bouncer, and good food was enjoyed by all.
- March 19, 2016, Veterans Health and Wellness Fair. Veterans Partnering with Communities and the Fontana Veterans Resource Center hosted this Co-sponsorship event at the Fontana Senior Center. There were 33 vendors with 200 community members attending.
- March 26, 2016, Easter Events at the following locations:
  - Fontana Park had egg hunts for children ages 3-12 with 9,000 eggs. Children 0-2 years of age or children that missed the egg hunt were able to collect eggs and candy at the information booth. There were games, an inflatable jumper, arts and crafts, face painting, and pictures with the Easter Bunny. Contract instructors from the center promoted their programs and distributed information about their classes. Water of Life Community Church at Summit provided 40 volunteers and awesome support for the event.
  - Cypress Neighborhood Center held its Easter Eggcitement event at Seville Park in a collaborative effort with City Link. Families who attended this free event were treated to game booths, arts and crafts, face painting, balloon animals, snow cones, stage entertainment, potato sack races, and pictures with the Easter Bunny. A complimentary pancake breakfast was provided by City Link volunteers. The annual Egg Hunt took place for children age 3-12 years of age. In each age group, three golden tickets were hidden among the eggs with grand prizes. Approximately 1,000 community members attended this event.
  - The Don Day Neighborhood Center hosted Easter Eggs-Travaganza with a pancake breakfast hosted by the Great Commission Baptist Church. The Easter egg hunt had over 400 participants, ages 3-12 years old and were also offered activities which included games, arts and crafts, pictures with the Easter bunny, class demonstrations, train rides, a jumper, interactive games with the Sports and Aquatics Divisions, a visit from the Nature Center, face painting and balloon animals by Mobile Recreation Division, activities with the San Bernardino County Library Bus, as well as a visit from the San Bernardino County Fire Department, and the 1952 Fontana Police Department Patrol Car. The event had over 1,200 participants in attendance.

Community Services Manager Jennifer Hunt provided a review of upcoming events as follows:

- May 6, 2016, Fontana Car Show, 5:00 p.m. to 9:00 p.m. at City Hall.
- May 14-15, 2016, Relay for Life, 9:00 a.m. to 9:00 a.m. at Summit High School.

Chairperson Espinoza spoke on the fun at the Easter Egg Hunts.

Commissioner Vaquera spoke on the success of the Easter Egg Hunt at Fontana Park.

Director Nelson recognized Karen Gerber and her staff for the great Easter Events.

**B. Tiny Tots Overview - Karen Gerber**

Community Services Supervisor, Karen Gerber, provided a Tiny Tots Overview as follows:

The Tiny Tots pre-school enrichment program is offered at four locations. It provides a healthy, fun, secure, creative, and exciting atmosphere for children ages three through five years of age who are fully potty trained. Activities are planned specifically for the progression of learning and socializing in a recreational setting, designed to create an environment where preschoolers can grow emotionally, intellectually, socially, and physically.

Pre-registration for the Tiny Tots program is required and spots are filled on a first-come, first-served basis. Currently enrolled participants get priority registration two weeks prior to the new session. Participants not currently enrolled and Fontana residents may begin to register one week prior to the session; and non-resident registration begins the Friday prior to the beginning of the session. An Activity Schedule is available online and at all Neighborhood and Community Centers.

The Tiny Tots program provides a warm, nurturing environment for children to grow and learn. Each child is unique with individual interests and needs. The Tiny Tots program is a recreational enrichment program, not a licensed daycare.

Tiny Tots staff receive on-going training to work with pre-school age youth. The participant to staff ratio of 5:1, we are able provide a most memorable experience to our youth.

Monthly emergency drills are conducted and includes fire, earthquake, and lock-down drills. Each site also practices evacuating from the building to a pre-determined evacuation site.

The Tiny Tots program is offered at Jessie Turner Health & Fitness Community Center; Heritage Neighborhood Center; Cypress neighborhood Center; and Don Day Neighborhood Center. Each center offers a unique environment for children to explore and have fun in a social and recreational setting.

Tiny Tots is offered twice a week for three hours per day.

Supervisor Gerber invited everyone to the Fontana After School Program Artist Showcase on Friday, May 20, 2016, at Steelworkers' Auditorium.

Supervisor Gerber spoke on programs available for parents while their children participate in Tiny Tots.

City Clerk Tonia Lewis thanked Director Nelson for his kind words.

City Clerk Lewis invited everyone to the Historical Society Quarterly Membership Meeting on Saturday at the Cypress Center.

City Clerk Lewis spoke on the National Day of Prayer Dinner on May 5, 2016, at the Hilton Garden Inn.

City Clerk Lewis congratulated new officers, Chairperson Espinoza; Vice-Chairperson Rowland, and Secretary Bravo.


City Clerk Lewis wished Commissioner Tigner well.
