A. Special Events Update – Kristy Samples

Community Services Supervisor Kristy Samples provided a report on special events conducted in May 2016:

- **Relay for Life, May 14-15, 2016, Summit High School.** This year's event raised over \$64,000 for the American Cancer Society; it has raised over one million dollars over the past sixteen years. This is a co-sponsorship event with the Fontana Unified School District.

- July 21, 2016, Summer Concert Series, Miller Park. Neon Nation will be performing.
- July 28, 2016, Summer Concert Series, Miller Park. Contemporary Praise Concert.
- July 30, 2016, 5:00 p.m. to 10:00 p.m., Sunset on Sierra in conjunction with the Arts Festival, Sierra Avenue from Spring Street to Orange Avenue.

Commissioner Rowland commented that Relay For Life has almost reached its fundraising goal of \$70,000.

Discussion was held on the Sunset on Sierra event that will have food trucks, activities, and vendors with Sierra Avenue being closed down from Upland Avenue to Ceres.

Commissioner Espinoza is excited to see this and will have lots of fun.

B. PEE WEE, YOUTH, & MIDDLE SCHOOL SPORTS UPDATE

Community Services Supervisor Geneo Ferrar and Community Services Coordinator Vanessa Cortez provided an update on Pee Wee, Youth and Middle School Sports.

The City of Fontana Sports Program's philosophy and mission stated were shared. The benefits of participation in the sports program was shared. Volunteers are an essential part of the sports programs.

The Pee Wee Sports programs are non-competitive, instructional based program offered to children between the ages of 1½ and 7. Programming is offered in Basketball, Soccer and T-Ball.

The Youth Sports programs are focused on teaching sports skills, terminology teamwork, sportsmanship and game strategy for youth 8 to 17 years old. Programming is offered in basketball and roller hockey.

Youth Sports has partnerships with the LA Clippers and Ontario Reign that offers special opportunities for participants.

The Middle School Sports program is a partnership with the Fontana Unified School

District to provide sports programs for middle school students at Alder, Almeria, Fontana, Ruble, Sequoia, Southridge, and Truman. Programming is offered in Volleyball, Basketball, and Soccer.

Participation in Pee Wee, Youth and Middle School Programs has increased from the previous year.
