

**MINUTES OF THE CITY OF FONTANA
REGULAR PLANNING COMMISSION MEETING
May 2, 2017
Grover W. Taylor Council Chambers**

CALL TO ORDER/ROLL CALL:

A. Call To Order/Roll Call:

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, May 2, 2017, in the Grover W. Taylor Council Chambers located at 8353 Sierra Avenue, Fontana, California. Chairperson Meyer called the meeting to order at 6:02 p.m.

A. Invocation/Pledge of Allegiance:

Following the Invocation given by Commissioner Vasquez, the Pledge of Allegiance was led by Secretary Sanchez.

A. Public Communications:

CONSENT CALENDAR:

A. Approval of Minutes:

Approve the Regular Planning Commission Meeting Minutes of April 18, 2017.

A motion was made by Commissioner Fort and seconded by Secretary Sanchez to approve the Minutes of the April 18, 2017, Planning Commission Meeting. Motion passed by a vote of 4-0.

PUBLIC HEARINGS:

A. Master Case No. 08-0058; Design Review Amendment Application No. 08-0010R1 - A request for site and architectural review of new carports and replacement of existing carports with new solar panel roof structures.

A motion was made by Secretary Sanchez and seconded by Commissioner Fort to collapse Public Hearing Items A, B, and C with separate action on each item. Motion passed by a vote of 4-0.

Assistant Planner Gabriel Salazar provided the staff report.

Vice Chairperson Quiroga asked about lighting or using existing light poles for the mailbox areas; applicant responded.

Discussion was held on the carports being strong enough to withstand the Fontana winds.

Discussion was held on whether the existing pillars would be used or be replaced; all are being replaced.

Secretary Sanchez requested information on the roof matching the existing building.

The Public Hearing was opened.

Speaking for the applicant, John Wood provided background information on his company; the carports are meeting wind, aesthetics conditions and standards, and being more attractive than the existing carports. This is a prototype for senior housing at no costs to seniors.

Roman Black spoke on the existing carports having lighting underneath with the existing lighting being removed and replaced with upgraded lighting.

Secretary Sanchez spoke on the new technology of solar tiles and the savings for seniors.

Mr. Black spoke on the customer selecting the color and using an accent color to the building to be aesthetically pleasing.

Discussion was held on who the applicant's customers are.

No member of the audience spoke in favor or opposition to this item.

The Public Hearing was closed.

ACTION: Motion was made by Secretary Sanchez and seconded by Commissioner Vasquez to adopt Resolution PC No. 2017-08; 1) Determine that this project qualifies for a Categorical Exemption pursuant to Section No 15332. (Class No. 32 In-Fill Development Projects) and Section No 15301 (Class No. 1 Existing Facilities) of the California Environmental Quality Act (CEQA) and direct staff to file a notice of exemption;

and 2) Approve Design Review No. 08-0010R1. Motion passed by a vote of 4-0.

B. Master Case No. 12-006; Design Review Amendment Application No. 12-005R2 - A request for site and architectural review of new carports and replacement of existing carports with new solar panel roof structures.

ACTION: Motion was made by Commissioner Fort and seconded by Commissioner Vasquez to adopt Resolution PC No. 2017-09; and 1) Determine that this project qualifies for a Categorical Exemption pursuant to Section No 15332. (Class No. 32 In-Fill Development Projects) and Section No 15301 (Class No 1 Existing Facilities) of the California Environmental Quality Act (CEQA) and direct staff to file a notice of exemption; and 1) Approve Design Review No. 12-005R2. Motion passed by a vote of 4-0.

C. Master Case No. 17-0017; Design Review Amendment Application No. 89-42R1 - A request for site and architectural review of new carports and replacement of existing carports with new solar panel roof structures.

ACTION: Motion was made by Commissioner Vasquez and seconded by Secretary Sanchez to adopt Resolution PC No. 2017-010; and 1) Determine that this project qualifies for a Categorical Exemption pursuant to Section No 15332. (Class No. 32 In-Fill Development Projects) and Section No 15301 (Class No 1 Existing Facilities) of the California Environmental Quality Act (CEQA) and direct staff to file a notice of exemption; and 2) Approve Design Review No. 89-42R1.

D. Master Case No. 16-005; Design Review No. 16-004 - A request for site and architectural review of an eight (8) unit apartment complex.

Senior Planner Paul Gonzales provided the staff report.

Staff received one call requesting information on the project.

Discussion was held on the fire places on the west elevation.

Discussion was held on the number of pop outs.

Discussion was held on the fountain; one is not proposed at this time.

Discussion was held on the tot lot amenities.

Vice Chairperson Quiroga asked if the house that burned nearby would be cleaned up; that property is not the applicants.

Discussion was held on the size of the garage.

Discussion was held on each unit having its own laundry room.

Commissioner Vasquez asked about additional iron accents; they can be found throughout the project.

Discussion was held on the mailbox location and lighting.

The Public Hearing was opened.

Speaking for the applicant, Saber Awad, spoke on continuing to develop in Fontana.

Commissioner Vasquez requested the barbeque be gas; Mr. Awad will install gas barbeques with safety features.

Secretary Sanchez commended the applicant on the project.

Discussion was held on the location and amenities of the tot lot.

Applicant has read, understood and agreed to the conditions of approval with the addition of lighting at the mail box area and child safety lock on the gas barbeque.

Secretary Sanchez requested a lattice roof be added to the top of the mail box area.

Speaking for the applicant, Luis Sermeno spoke on the location of the lighting and the mail boxes.

Merle Kauffman spoke in opposition to the project due to the traffic congestion.

The Public Hearing was closed.

ACTION: Motion was made by Secretary Sanchez and seconded by Commissioner Vasquez to adopt Resolution PC No. 2017-11; and 1) Determine that this project qualifies for a Categorical Exemption pursuant to Section No 15332. (Class No. 32, In-Fill Development Projects) of the California Environmental Quality Act (CEQA) and direct staff to file a notice of exemption; and 2) Approve Design Review No. 16-004 with the addition of barbeque gas operated with safety feature and a trellis with lighting above the mailbox area. Motion passed by a vote of 4-0.

E. Design Review Sign No. 17-021 - A request to amend the existing Sign Program for the Summit Heights Gateway Shopping Plaza.

Senior Planner DiTanyon Johnson provided the staff report.

The Public Hearing was opened.

Speaking for the applicant, Connie O'Connor.

Discussion was held on how often the lighting goes out and how long it takes to replace; and the monitoring of the lights.

Discussion was held on the water feature.

The applicant some on the spaces still to be leased with stores in the back area that need the signage to get people back there and interested in leasing.

Discussion was held on the primary material for the sign; it will be a well-constructed sign, tasteful and clean.

Applicant has read, understood and agreed to the conditions of approval.

No member of the audience spoke in favor or opposition to this item.

The Public Hearing was closed.

ACTION: Motion was made by Commissioner Vasquez and seconded by Commissioner Fort to adopt PC Resolution No. 2017-12 and 1) Determine that the project is Categorically Exempt pursuant to Section No.15303, Class 3, (New Construction of Small Construction) of the California Environmental Quality Act, direct staff to file a Notice of Exemption; and, 2) Approve Design Review Sign No. 17-021. Motion passed by a vote of 4-0.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind
