

**CITY OF FONTANA
PARKS AND COMMUNITY SERVICES COMMISSION
REGULAR MEETING
MAY 25, 2017**

The City of Fontana Parks and Community Services Commission and Staff met for a workshop at 6:00 p.m. on Thursday, May 25, 2017, in the City Council Chambers, 8353 Sierra Avenue, Fontana, California, prior to the regular meeting to review the agenda, Co-Sponsorship applications and an orientation on voting.

The regular meeting of the City of Fontana Parks and Community Services Commission was held on Thursday, May 25, 2017, in the Grover W. The meeting was called to order at 7:08 p.m. by Chairperson Rowland, followed by an Invocation given by Pastor David Zamora, Living Way Christian Fellowship, and the Pledge of Allegiance led by Chairperson Rowland.

NEW BUSINESS:

A. SPECIAL EVENTS UPDATE - ROB BOCK

Community Services Supervisor Rob Bock provided a report on special events conducted in April:

- April 7, 2017; Fontana Car Show at City Hall. There were 275 participants and 70 cars.
- April 8, 2017; Veterans Health and Wellness Resource Fair at Fontana Senior Center. This event was co-sponsored with the Veterans Partnering with Communities and provided veterans with housing, health, and financial resources. There were over 150 participants.
- April 15, 2017; Easter Event at Fontana Park. The Summit Water of Life Church hosted an Easter Egg Hunt and Open House in partnership with Jessie Turner Health and Fitness Community Center. Events included an egg hunt, pictures with the Easter Bunny, games, crafts, inflatable jumpers, class demonstrations, vendors, music, face painting, balloon animals, and free drawings. There were over 2,000 participants.
- April 15, 2017; Easter Event at Seville Park. There were over 1,000 participants at this event with egg hunts, games, arts and crafts, face painting, air brush tattoos and balloon animals, pictures with the Easter Bunny and entertainment.
- April 15, 2017; Easter Event at Southridge Park. The Don Day Neighborhood Center hosted an Egg-Hunt with a Pancake Breakfast provided by the Great Commission Church. There were over 900 participants. Events included a

pancake breakfast, egg hunts, games, inflatables, face painting, arts & crafts, and class performances.

- April 21, 2017; Community Assistance Program Resource Fair at Jack Bulik Park. This event was co-sponsored with the Community Assistance Program through the Water of Life Church. Over 86 representatives from community assistance organizations serviced over 150 residents. Participants received information on disability and education programs, health services, financial services, medical services and senior services.

Community Services Supervisor Rob Bock provided a review of upcoming events as follows:

- June 1-4, 2017; Fontana Days Festival at Veterans Park. This is co-sponsorship with the Fontana Exchange Club. There will be carnival rides, food vendors and entertainment. Family Night will be held on Thursday, June 1, 2017, with a \$1 admission fee and \$1 rides.
- June 3, 2017; Fontana Days Run at City Hall. The half-marathon is sold out, but there is still availability in the 5K run, run/walk and walk.
- June 3, 2017; Fontana Days Parade on Sierra from Arrow to Merrill. This event is hosted by the Fontana Exchange Club.
- June 10, 2017; Miss Fontana Scholarship Pageant at Rancho Cucamonga Performing Arts Center. This is a co-sponsored event with the Fontana Rotary Club. Due to construction at Fontana High School, it is being held at a different location.
- June 17, 2017; Love Fontana at Jack Bulik Park. This is a co-sponsored event with the Calvary Chapel Summit Church.
- June 8, 15, 22 & 29, 2017; Summer Concerts Series at Veterans Park. The venue has changed due to construction at Miller Park. Bands playing will be Soto, Neon Nation, Yard Sale, and Tom Nolan Band. There will be family activities, jumpers, train rides, and food vendors.

ACTION: Motion was made by Commissioner Key, seconded by Commissioner Vaquera, and passed by a vote of 6-0 to receive and file New Business Item A.

B. KFON PROGRAMMING UPDATE – ANTHONY SARINANA

Community Services Production Coordinator Anthony Sarinana provided an update on KFON TV programming and services.

KFON staff covers City Council, Planning, and Parks & Community Services Commission Meetings, City Events, Community Events, and provide a Community Bulletin Board and Audio Support.

Accomplishments include 20 episodes of “Open for Business” and “Local Matters” programs; production of 12 “Eat Healthy, Fontana!” cooking shows; College Internship Program, and 152 productions.

KFON-TV Studio has high definition capabilities, a green screen, studio sets, 10 edit workstations, a voice-over room, a master control room, and a green room.

The KFON-TV Production Van is a mobile studio with high definition capabilities, multi-camera coverage of events, and self-sustained power with a generator and inverter.

KFON-TV has a social media presence that allows viewer interaction.

KFON-TV Channels include Spectrum Cable channel 3; Frontier Communications channel 38; AT&T U-Verse channel 99; and KFON-TV website: KFON.org

Commissioner Vaquera asked if KFON ever spotlights individuals in the Community. Some community members have been spotlighted and other human interest stories are also covered.

Commissioner Jones asked if high school coverage is provided. Only City business can be covered on the KFON government channel. The School Board channel and the Herald News cover high school sports.

The programming schedule is available on KFON.

C. SUMMER FOOD PROGRAM PREVIEW 2017 - JENNIFER HUNT GRACIA

Community Services Manager Jennifer Hunt Gracia provided a preview of the 2017 Summer Food Program.

The Summer Food Program will run from May 30 to July 21, 2017, from 10:30 a.m. to 1:00 p.m. with times varying by location.

The program will be offered at 20 locations including, eight schools, nine parks, and three additional facilities.

All meals meet SB-12 requirements of a nutritious meal and it is estimated that 90,000 meals and snacks will be served.

The Summer Food Program is run in collaboration with the Fontana Unified School District and is free for anyone 18 and under.

Chairperson Rowland commented that it is her favorite collaboration and one of the best programs in the City.

ACTION: Motion was made by Commissioner Jones, seconded by Commissioner Key, and passed by a vote of 6-0 to receive and file New Business Item C.

D. CO-SPONSORSHIPS FOR FISCAL YEAR 2017-2018 - ROB BOCK

Community Services Manager Rob Bock provided a staff report on Co-Sponsorship applications for the Parks and Community Services Commission's review and recommendation.

The Parks and Community Services Commission requested

Review and provide City Council with a recommendation regarding twenty-two Co-Sponsorship applications for fiscal year July 1, 2017 through June 30, 2018 totaling an amount up to \$45,003.

Director Garth Nelson shared that each Commissioner prioritized the co-sponsorship applications and a consensus was reached.

Chairperson Rowland shared the prioritized list.

ACTION: Motion was made by Commissioner Key, seconded by Commissioner Jones, and passed by a vote of 6-0 to recommend the co-sponsorship applications as prioritized to the City Council for approval.

ACTION: Motion was made by Commissioner Vaquera, seconded by Commissioner Key, and passed by a vote of 6-0 to recommend the facility usage applications to the City Council for approval.

ACTION: Motion was made by Commissioner Key, seconded by Commissioner Rowland, and passed by a vote of 6-0 to not fund No. 16 (The Concerned Citizens for the Development of North Fontana Black History Parade) and to reduce the amount of funding for No. 13 (Begin from Within, Family Matters Community Picnic) to \$2,277 from \$3,454 with the excess being moved to No. 14 (Fontana Community Assistance Program, CAP Appreciation Celebration) \$198 and No. 15 (The Concerned Citizens for the Development of North Fontana, Black History Expo) \$979.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
