NEW BUSINESS:

A. VPOP & FIELD MANAGEMENT - GENE0 FARRAR:

Community Services Supervisor Geneo Farrar provided a Field Management Program Overview and the new VPOP program in collaboration with the Fontana Police Department.

The Field Management Program requesting, monitoring and auditing all field usage. Staff receives, reviews and approves requests, enters permits, communicates with user groups, audit user groups and field conditions as well as monitor 45 athletic fields.

Field Monitors are equipped with handheld tablets that can generate work requests, amend permits, change light schedules, and report vandalism.

In February 2017, the City of Fontana implemented VPOP & Field Management Program in collaboration with the Fontana Police Department to patrol city parks.

The goals of the VPOP program include become familiar with parks and its patrons; interact positively with community members to build lasting relationships; patrol "hot spots" to resolve issues; and provide extra "eyes & ears" within park perimeters to report abnormal or suspicious activities.

VPOP members only observe and report as they are not City employees and have no police authority.

Supervisor Farrar shared information on the qualifications for and how to become a VPOP member. .

These programs work together to keep parks safe for the community.

D. FACILITY RENTAL OVERVIEW - KAREN GERBER:

Community Services Supervisor Karen Gerber provided a Facility Rental Overview.

There are many venues available to rent for a variety of special occasions with many amenities. Patrons may visit or call any facility or email rentals@fontana.org for information on rentals. City staff will provide patrons with the best resources and opportunities available.

Fees are based on classification, Non-Profit Group, Fontana Residents or Non-Residents or for Profit Businesses, and include a facility deposit, alcohol deposit, hourly room rate, insurance, warming kitchen, and security guards.

Facilities available include the Steelworkers' Auditorium, Art Depot Gallery, Heritage Neighborhood Center, Cypress Neighborhood Center and Josephine Knopf Center, Don Day Neighborhood Center, Fontana Community Senior Center, and Jesse Turner Health and Fitness Community Center.

There was a 4% increase in rentals from 2015 to 2016.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of your DocuSign account. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use your DocuSign Express user account to receive required notices and consents electronically from us or to sign electronically documents from us.
