MARCH 7, 2018
MINUTES**

CALL TO ORDER/ROLL CALL:

A. CALL THE MEETING TO ORDER AT 5:30 PM

A Special Fontana Parks and Community Services Commission Meeting was held on Wednesday, March 7, 2018, in the Fontana City Hall Executive Conference Room at 8353 Sierra Avenue, Fontana, California. The meeting was called to order by Community Services Director, Garth Nelson, at 5:32 pm.

ROLL CALL

Present: Commission Vice-Chair Quintana, Commissioners Ahumada, Jones, Key, and Sangha.

Absent: Chair Rowland and Commissioner Vaquera.

B. PUBLIC COMMUNICATIONS

None.

C. WORKSHOP

Director of Community Development, Zai AbuBakar and Senior Planner, Dawn Rowe presented a report on the City of Fontana General Plan Amendment.

Discussion ensued regarding the following aspects of the General Plan:

Commissioner input and edits.

Commissioner Jones inquired about the origination of comments/notations on page 155.

Commission Key inquired about the timeline for additional community input.

Commissioner Jones asked if the General Plan would be updated to include “modernizing” language and brought up to date with current laws/code.

Director Zai AbuBakar responded the scope can be broadened to include an example while maintaining the focus of edits to allow future development.

Commissioner Key asked if restroom signs would be updated due to new laws related to gender.

Public Works Manager Dan West will look into single restroom signs with multiple genders indicated.

Director Garth Nelson suggested edits to focus on inclusion.

Commissioner Jones inquired about the number of dog parks and if there were any in the southern part of the city.

Director Zai AbuBakar responded that there was one with more in process, all in the northern part of the city.

Commissioner Quintana inquired if a blue square on Page 148, above the 210 freeway was a potential location for a new park.

Director Garth Nelson responded that the section is in reference to an area located behind Home Depot. Director Nelson also commented softball/baseball facilities were discussed at the City Council Goal Setting meeting and will be good feedback for the upcoming Park Master Plan.

Public Works Manager Dan West indicated that the Park Master Plan process would begin in 2018. The process would provide the opportunity for greater detail of park development.

Director Garth Nelson thanked the Commissioners for their comments.

Director Garth Nelson thanked Director Zai AbuBakar and Senior Planner Dawn Rowe for the General Plan presentation.

D. Commissioner Comments

Commissioner Sangha asked whether or not the GPAC committee was private and if was still possible to join.

Commissioner Key asked if the Parks and Community Services Commission was represented on the committee.

It was indicated that the committee still existed but may not be meeting currently.

Commissioner Jones offered appreciation for Director Zai AbuBakar, Senior Planner Dawn Rowe, CSD Manager Michael Wright, and CSD Manager Daniel Schneider.

Commissioner Key commented that the Black History Parade was enlightening, regarding participation and resources. She further commented that attending was a quality experience and evaluation was needed to determine how much help the group would need for future events. In addition, fiscal spending was wasted without an audience, questioned fiscal viability and sustainability; worthwhile event but concerned about the group getting an audience.

Commissioner Quintana agreed.

Commissioner Key was willing to help the group but not if a conflict of interest would be created.

Commissioner Ahumada thanked everyone for the GPAC information, enjoyed the Teen Summit, liked the College Resource Fair, and would be attending Southridge and Jack Bulik Little League, openings ceremonies.

Commissioner Quintana thanked CSD Manager Daniel Schneider and Public Works Manager Dan West for Bill Martin Park, field #5 fix. Also added that people were not aware of the Field

Monitoring Program or the phone number to contact them and asked if the phone number was posted at the parks.

Director Garth Nelson responded that the park monitor phone number was issued to all permitted users and added that the Department would look into another method to let the public know. Possibly list on KFON as a non-emergency number or post the number on social media.

Commissioner Key asked if the Commission had a Facebook page.

Commissioner Sangha requested an update on the gang activity shooting at Jack Bulik Park.

CSD Manager Schneider replied the department is working with the Police Department to assist park safety efforts. The Police Department has actively taken measures to investigate the occurrence.

CSD Manager Daniel Schneider announced upcoming Arbor Day event on March 29th at Mary Vagle Nature Center. Little League Opening Ceremonies were scheduled but could be cancelled due to rain. He instructed Commissioners to let him know if they planned to attend.

CSD Manager Wright provided a Memo regarding a customer Registration Policy complaint. He stated staff reached out to customer to inform them of department resident registration guidelines.

CSD Manager Kristy Samples thanked those who attended the Leadership Summit.


Director Garth Nelson announced that the annual Commission Reorganization would take place at the next Regular meeting.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of your DocuSign account. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use your DocuSign Express user account to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through your DocuSign user account all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

We do not require any other information from you to change your email address..

In addition, you must notify DocuSign, Inc to arrange for your new email address to be reflected in your DocuSign account by following the process for changing e-mail in DocuSign.

To request paper copies from City of Fontana

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an e-mail to cteveda@fontana.org and in the body of such request you must state your e-mail address, full name, US Postal address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with City of Fontana

To inform us that you no longer want to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your DocuSign account, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an e-mail to cteveda@fontana.org and in the body of such request you must state your e-mail, full name, US Postal Address, telephone number, and account number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
