

**MINUTES OF THE CITY OF FONTANA
REGULAR PLANNING COMMISSION MEETING
July 17, 2018
Grover W. Taylor Council Chambers**

CALL TO ORDER/ROLL CALL:

A. Call To Order/Roll Call:

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, July 17, 2018, in the Grover W. Taylor Council Chambers located at 8353 Sierra Avenue, Fontana, California. Chairperson Sanchez called the meeting to order at 6:01p.m.

A. Invocation/Pledge of Allegiance:

Following the Invocation given by Commissioner Vasquez, the Pledge of Allegiance was led by Vice Chairperson Quiroga.

CONSENT CALENDAR:

A. Approval of Minutes:

Approve the Regular Planning Commission Meeting Minutes of June 19, 2018.

Approve the Regular Planning Commission Meeting Minutes of June 19, 2018, meeting with revisions provided by Director AbuBakar.

ACTION: A motion was made by Commissioner Vasquez and seconded by Commissioner Fort to approve the Minutes of the June 19, 2018, Planning Commission Meeting. Motion passed by a vote of 4-0. (AYES: Sanchez, Quiroga, Fort and Vasquez; NOES: None; ABSTAIN: None)

PUBLIC HEARINGS:

- A. Master Case No. 17-067; General Plan Amendment No. 17-006; Zoning Code Amendment No. 17-005; Tentative Parcel Map No. 17-012; Conditional Use Permit No. 17-033; Design Review No. 17-030 - A request to receive comments on the Draft Environmental Impact Report (DEIR) [State Clearinghouse No. 2018041008] for a 376,910 square foot warehouse logistics building and the rezoning of the three (3) adjacent parcels.**

Assistant Planner Alejandro Rico provided the staff report.

The Public Hearing was opened.

Speaking for the applicant, Scott Irwin, spoke on another project he worked with staff on in Fontana and commended staff for all their work.

The Public Hearing was closed.

ACTION: No action required on this item.

- B. Master Case No. 18-051; Conditional Use Permit No. 18-013 - A request for review and approval of a Conditional Use Permit (CUP) to establish a day care facility for a maximum of 14 children.**

Assistant Planner Alejandro Rico provided the staff report.

Discussion was held on the swimming pool area being gated.

Discussion was held on Building and Safety, the Fire Department and State Social Services reviewing and inspecting the site.

Discussion was held on neighbors' concerns.

Discussion was held on the "u" shaped driveway.

Discussion was held on the traffic congestion on Juniper Avenue and having the applicant work with the corner business to allow parents to park there to avoid congestion. Planning Manager Hernandez shared that the applicant cannot be conditioned to require customers to park on property they do not control.

Director AbuBakar stated that not all parents are picking up their children at the same time.

Discussion was held on how long the day care service has been in business and any calls for service.

The Public Hearing was opened.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

Discussion was held on the impact on traffic with the addition of more children. Planning Manager Hernandez spoke on the Engineering Department monitoring for any traffic issues.

ACTION: Motion was made by Commissioner Vasquez and seconded by Commissioner Fort to adopt **Resolution No. PC 2018-045**; and 1) Determine that the project is statutorily and categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section No. 15274 (Family Day Care Homes), and direct staff to file a Notice of Exemption; and, 2) Approve Conditional Use Permit No. 18-013 subject to the attached Findings and Conditions of Approval. Motion passed by a vote of 4-0. (AYES: Sanchez, Quiroga, Fort, and Vasquez; NOES: None; ABSTAIN: None)

C. Master Case No. 17-046; Tentative Tract Map No. 20077 (TTM No. 17-008) - A proposal to subdivide two (2) parcels totaling approximately 4.7 adjusted gross acres into 19 lots for the purpose single family homes.

Associate Planner Jon S. Dille provided the staff report.

Discussion was held on the size of the lots.

Discussion was held on the zoning for the property and the lot size.

The Public Hearing was opened.

Speaking for the applicant, Brett Blazicek.

Applicant has read, understood and agreed to the conditions of approval.

Dennis Turnbull requested information on the alley behind the project.

The Public Hearing was closed.

Discussion was held on the naming of Hibiscus Street.

ACTION: Motion was made by Chairperson Sanchez and seconded by Vice Chairperson Quiroga to adopt **Resolution No. PC 2018-046**, and: 1) Determine that the project is Categorically Exempt pursuant to Section No. 15332, (Class No. 32, In-Fill) of the CEQA, and direct staff to file a Notice of Exemption; and, 2) Approve Tentative Tract Map No. 20077. Motion passed by a vote of 4-0. (AYES: Sanchez, Quiroga, Fort, and Vasquez; NOES: None; ABSTAIN: None)

D. Master Case No. 18-004; Tentative Tract Map No. 20153 - A request to subdivide approximately 135 acres into 11 lots for future subdivision and development as part of the Summit at Rosena Specific Plan.

Senior Planner DiTanyon Johnson provided the staff report.

Discussion was held on minimum lot size requirement.

Discussion was held on the intent of the project and establishing the planning areas.

Discussion was held on the number of anticipated parks in the area.

Discussion was held on the call received by staff regarding the type of development.

Discussion was held on the development being a gated community; and the project is not required to be gated.

The Public Hearing was opened.

Speaking for the applicant, Derek Barber, spoke on working with staff on the project and confirmed that purpose of the project.

Applicant has read, understood and agreed to the conditions of approval.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

ACTION: Motion was made by Commissioner Vasquez and seconded by Commissioner Fort to adopt **Resolution No. PC 2018-047**, and 1) Find that the project has been reviewed under the previous Environmental Impact Report for the associated Summit at Rosena Specific Plan and has adequately identified the impacts associated with the project, pursuant to Section 15162 of the CEQA Guidelines and direct staff to file a Notice of Determination; and, 2) Approve Tentative Tract Map No. 20153. Motion passed by a vote of 4-0. (AYES: Sanchez, Quiroga, Fort, and Vasquez; NOES: None; ABSTAIN: None)

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of your DocuSign account. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use your DocuSign Express user account to receive required notices and consents electronically from us or to sign electronically documents from us.
