### **NEW BUSINESS:**

#### **A. HEALTHLY FONTANA UPDATE – JASMINE SARSADIAS**

Community Services Coordinator Jasmine Sarsadias provided an update on Healthy Fontana.

Since its launch in 2004 Healthy Fontana has received high honors for its efforts to enrich the quality of life for Fontana residents.

The four core components of the Healthy Fontana Program are Nutrition, Active Living, Smart Growth, and Community Partnerships.

In the areas of nutrition and active living, Healthy Fontana educates the community on healthy living with an emphasis on consuming more fruits and vegetables and engaging in regular physical activity.

Throughout the school year, Healthy Fontana reaches over 3,000 elementary and middle school students through the Fontana Expanded Learning Program.

Mobile Fresh is known as a grocery store on wheels and is operated by Family Services Association; it brings the convenience of a grocery store with the freshness of a farmer's market to residents. Mobile Fresh has served over 1,200 customers and sold over \$6,200 of fresh fruits, vegetables and whole grains.

The Healthy Jr. Chef Cooking Class was expanded by adding a summer series at Siena Apartments; 85 young chefs between the ages of 8 and 14 have learned safe and sanitary food handling and cooking techniques; and have learned how to navigate kitchen tools.

Healthy Fontana provided education at eight summer camp sites throughout Fontana providing lessons on synergistic fruit and veggie combinations, MyPlate, and the dangers of commonly consumed drinks and fats, through interactive games and activities to 1,600 students.

Chef Saundra has been teaching viewers how to cook healthy and delicious recipes for over 10 years through the 'Eat Healthy, Fontana!' Cooking show. Viewers were introduced portabella lentil quinoa burgers, vegetable omelet, Greek yogurt parfaits, and light mushroom chicken with roasted parsnip puree. The show has been viewed over 400 times on YouTube.

Fontana Walks celebrated its one year anniversary on August 18, 2018. Over 235 participants helped celebrate this commemorative event including vendors who participated in a resource fair following the walk. The program began when Healthy Fontana was awarded a grant from the American Association of Retired Persons (AARP) to help engage the community to be more physically active for overall health. The program successfully superseded that goal of two billion steps during the year with over 3.2 billion steps. Over 1,400 participants have registered for the Fontana Walks! program and many have participated in monthly community walks.

In June 2018, Healthy Fontana received a Community Health Grant from Kaiser Permanente to help extend and expand the Fontana Walks! program to include healthy food samples at each walk. This year, the program is also raising awareness about the benefits of CalFresh.

Efforts around environmental change and policy can be seen through Healthy Fontana's work with the retail environment. Through funding by the San Bernardino County Department of Public Health, Healthy Fontana works with large and small retail settings to increase access to healthy fruits, vegetables, and beverages through adopted and implemented policy and physical site changes.

This summer, Healthy Fontana was able to get La Tricolor on board with the SHOP Healthy Here Retail Recognition program. Healthy Fontana has been able to work with the owner to make changes in the store including relocating produce and signage throughout the store promoting fruits and vegetables. Healthy Fontana has also been on site to provide food demonstrations utilizing ingredients found in La Tricolor store. As a SHOP Healthy Here Retail Program Partner, La Tricolor has agreed to maintain changes to their store layout including healthy produce displays, displaying healthy promotional materials, display price tags for healthy food options, providing space for in-store activities and working to reduce the number of advertisements that promote unhealthy food and beverages as well as alcohol and tobacco. La Tricolor will be receiving a new freezer unit through San Bernardino County for participating in this grant program. Educational materials and information are being shared at Superior and Stater Bros. Markets.

The Healthy Fontana program maintains success by partnering with over 150 local, regional and statewide organizations to spread the word of good health. Partners include community based, non-profit organizations, and local businesses; and with other departments within the city including but not limited to the Planning Department, Fire Department and Police Department.

Healthy Fontana has participated in over 35 community events raising awareness and

sharing information and resources about healthy living to those in need.

In 2019, Healthy Fontana will be working on building an even healthier Fontana. With a recently adopted General Plan, Healthy Fontana will continue to address health and wellness within Fontana including goals for future physical development that will result in a healthier city and a vision to become one of “the healthiest and most sustainable cities in San Bernardino County.”

## **B. PUBLIC PARKS SMOKING ORDINANCE - ORAL REPORT - MICHAEL WRIGHT**

Community Services Manager Michael Wright provided an oral report on the Public Parks Smoking Ordinance.

Concerns with public park smoking were brought to the City Council who directed staff to work with the citizens and the Parks, Community and Human Services Commission to develop an ordinance that could be adopted. The City ordinance was adopted on September 30, 2018.

The new ordinance expanded on the California State Law, creates a healthier environment for families, coincides with Healthy Fontana initiatives, and is consistent with surrounding agencies.

Staff will be educating the community through public engagement, press releases, social media and signs posted in City of Fontana parks.

Discussion was held on the cost to the City for this ordinance; the cost was minimal.

Discussion was held on enforcement of the ordinance.

Commissioner Quintana congratulated the citizens that brought the concern forward.

Director Nelson spoke on staff providing a report on the signage cost of the ordinance.

## **C. Special Events Update – Rob Bock**

Community Services Supervisor Rob Bock provided a report on special events conducted in October 2018:

- October 6, 2018, Hispanic Heritage Celebration, Miller Amphitheatre: La Gran Fiesta was a celebration of Hispanic culture with an event that included artists, community booths, interactive art activities that featured art by Hispanic artists, a live sidewalk chalk artist, a loteria booth, a kid's zone, a main stage with music and dance performances, and food vendors. There were approximately 1,800 people in attendance.
- October 13, 2018, Youth Summit, Jessie Turner Health & Fitness Center: This co-sponsorship event with The New Environmental Leaders of America brought together students in grades 8 through 12 with industry professionals and provided an opportunity for them to interact with hands on experiments and demonstrations on air pollution, recycling, water contamination, renewable energy and a solar powered car demonstration. There were over 80 students participating in the event.
- October 20, 2018, Fontana Park 10<sup>th</sup> Anniversary: The Summit High School Orchestra kicked off the event. There was a Halloween Howl with a day of fun for furry friends which included a costume contest, pet adoption, K-demos, low cost pet vaccinations, music, pet vendors and more. There were 3,500 participants in attendance.
- October 27, 2018, Agua Caliente Clipper Game, Jessie Turner Health & Fitness Center: The NBA G League Agua Caliente Clippers played the Salt Lake City Stars in a free event that was attended by 300 guests with each receiving a drawstring bag, being entered in a drawing for an autographed hat, and having an opportunity to receive an autograph and picture with the players.
- October 31, 2018, Halloween Spooktacular, Jessie Turner Health & Fitness Center: This was a collaborative event with Calvary Chapel Summit Church and was held indoors. Participants enjoyed a costume contest, games, crafts, trick or treating, music, food, a roving photo booth, and more. In addition, the Fontana Park Aquatic Center hosted a Haunted Maze that had 831 participants. There were a total of 3,200 participants in both events.
- October 31, 2018, Festival of Frights, Cypress Neighborhood Center: This event had a total of 1,190 participants that enjoyed games and activities, a costume contest, a magician, raffles, and a Trunk or Treat in the Josephine Knopf Center with several uniquely decorated tables from Chick-fil-a, Les Schwab Tires, and the City of Fontana Fire Department.
- October 31, 2018, Monster Mayhem Halloween Event, Don Day Community Center: Volunteers from Kaiser High School, welcomed nearly 900 participants to enjoy games, crafts, raffles, food, a costume contest, taco and snow cone vendors, and game booths.
- October 31, 2018, Halloween Event, Jack Bulik Neighborhood Center: The 2<sup>nd</sup> Annual Halloween Day of the Dead Mash Up offered a safe and fun

environment for families to collect candy, participate in carnival style games and participate in costume contests and enjoy The Day of The Dead decorations and Taekwondo demonstrations. Over 2,000 community members participated.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
