

**MINUTES OF THE CITY OF FONTANA
REGULAR PLANNING COMMISSION MEETING
February 19, 2019
Grover W. Taylor Council Chambers**

CALL TO ORDER/ROLL CALL:

A. Call To Order/Roll Call:

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, February 19, 2019, in the Grover W. Taylor Council Chambers located at 8353 Sierra Avenue, Fontana, California. Chairperson Sanchez called the meeting to order at 6:01 p.m.

Present: Chairperson Sanchez; Vice Chairperson Quiroga; Secretary Fort; Commissioners Garcia and Sangha joined the Commission at the dais after being sworn in.

A. Invocation/Pledge of Allegiance:

Following the Invocation given by Commissioner Fort, the Pledge of Allegiance was led by Commissioner Quiroga.

A. Oath of Affirmation of Allegiance:

Commissioner Angela Garcia was sworn in as a Planning Commissioner by Fontana School Board Member Peter Garcia.

Commissioner Raj Sangha was sworn in as a Planning Commissioner by Mayor Warren.

PUBLIC COMMUNICATIONS:

A. Public Communications:

Donna Horowitz spoke on restrictions on solar panels on residential homes and requested information on Code enforcement of this item. Staff was directed to speak with Ms. Horowitz.

CONSENT CALENDAR:

A. Approval of Minutes:

Approve the Regular Planning Commission Meeting Minutes of February 5, 2019.

ACTION: A motion was made by Commissioner Fort and seconded by Vice Chairperson Quiroga to approve the Minutes of the February 5, 2019, Planning Commission Meeting. Motion passed by a vote of 3-0-2. (AYES: Sanchez, Quiroga, Fort; NOES: None; ABSTAIN: Garcia, Sangha)

PUBLIC HEARINGS:

A. Master Case No. 18-092; Design Review No. 18-024 - Design Review is a request to construct nine (9) single-family homes within previously approved Tract Map No. 20176 (TTM No. 18-004).

Assistant Planner Fernando Herrera provided the staff report.

Discussion was held on the block wall at the end of the cul-de-sac.

The Public Hearing was opened.

Speaking for the applicant, Doug Andresen spoke on the use of a decorative block wall on the perimeter of the project.

Applicant has read, understood and agreed to the conditions of approval.

Discussion was held on the front and side setbacks.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

ACTION: Motion was made by Commissioner Fort and seconded by Commissioner Sangha to adopt **Resolution PC No. 2019-011**; 1) Find that the project is Categorically Exempt pursuant to Section No. 15301, Class No. 32, (In-Fill Development) and Section No. 3.21 of the 2018 Local Guidelines for Implementing the California Environmental Quality Act (CEQA), and direct staff to file a Notice of Exemption; and, 2) Approve Design Review No. 18-024, for site and architectural review of nine (9) single-family homes. Motion passed by a vote of 5-0. (AYES: Sanchez, Quiroga, Fort, Garcia and Sangha; NOES: None; ABSTAIN: None)

B. Master Case No. 18-091; Time Extension for Tentative Tract Map No. 18974 (TTM No. 14-002EX); Design Review No. 18-025 - Tentative Tract Map

Extension is a request for a two (2) year time extension for the previously approved Tentative Tract Map No. 18974. Design Review is a request to construct five (5) single-family homes within previously approved Tract Map No. 18974 (Tentative Tract Map No. 14-002).

Assistant Planner Fernando Herrera provided the staff report.

Discussion was held on the blue color palette proposed on one of the homes.

Discussion was held on the project being on septic versus sewer.

The Public Hearing was opened.

Speaking for the applicant, Doug Andresen spoke on connecting to the sewer when it is available and the color palette being appropriate.

Applicant has read, understood and agreed to the conditions of approval.

Commissioner Sanchez asked that the applicant bring actual color charts for future projects.

Discussion was held on the large sized lots.

Discussion was held on the date of ground breaking.

Dana Cunningham spoke in opposition to the project and would like it to match the other single stories in the area.

The Public Hearing was closed.

ACTION: Motion was made by Commissioner Garcia and seconded by Commissioner Quiroga to adopt **Resolution PC No. 2019-012**; 1) Find that the project is exempt pursuant to Section No. 15332, Class No. 32, (In-Fill Development) of the California Environmental Quality Act and Section No. 3.21 of the 2018 Local Guidelines for implementing the California Environmental Quality Act, and direct staff to file a Notice of Exemption; and, Approve a two (2) year time extension for Tentative Tract Map No. 18974 (TTM No. 14-002EX), extending the expiration date to October 18, 2020; and, 2) Approve Design Review No. 18-025 for site and architectural review of five (5) single-family homes. Motion passed by a vote of 5-0. (AYES: Sanchez, Quiroga, Fort, Garcia and Sangha; NOES: None; ABSTAIN: None)

C. Master Case No. 18-097; Tentative Tract Map No. 20230 (TTM No. 18-012) - Tentative Tract Map No. 20230 is a proposal to subdivide one (1) parcel of approximately 3.0 adjusted gross acres into 12 lots for future development of single-family homes.

Associate Planner Jon S. Dille provided the staff report.

The Public Hearing was opened.

Speaking for the applicant, Neal Brimhall.

ACTION: Motion was made by Commissioner Fort and seconded by Commissioner Sanchez to adopt **Resolution PC No. 2019-013**; 1) Determine that the project is Categorically Exempt pursuant to Section No. 15332, (Class No. 32, In-Fill) of the CEQA, and Section No. 3.21 (Certain Infill Projects) of the Local Guidelines for Implementing the California Environmental Quality Act, 2018 and direct staff to file a Notice of Exemption; and, 2) Approve Tentative Tract Map No. 20230. Motion passed by a vote of 5-0. (AYES: Sanchez, Quiroga, Fort, Garcia and Sangha; NOES: None; ABSTAIN: None)

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent
