

**MINUTES OF THE CITY OF FONTANA
REGULAR PLANNING COMMISSION MEETING
May 21, 2019
Grover W. Taylor Council Chambers**

CALL TO ORDER/ROLL CALL:

A. Call To Order/Roll Call:

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, May 21, 2019, in the Grover W. Taylor Council Chambers located at 8353 Sierra Avenue, Fontana, California. Chairperson Quiroga called the meeting to order at 6:02 p.m.

A. Invocation/Pledge of Allegiance:

Following the Invocation given by Commissioner Garcia, the Pledge of Allegiance was led by Vice Chairperson Fort.

CONSENT CALENDAR:

A. Approval of Minutes:

Approve the Regular Planning Commission Meeting Minutes of May 7, 2019.

ACTION: A motion was made by Vice Chairperson Fort and seconded by Commissioner

Garcia to approve the Minutes of the May 7, 2019, Planning Commission Meeting. Motion passed by a vote of 3-0. (AYES: Quiroga, Fort, Garcia; NOES: None; ABSTAIN: None)

PUBLIC HEARINGS:

A. 2019/2020-2025/2026 Preliminary Capital Improvement Program (CIP)

Resource Budget Officer Lynn Rogers provided the staff report.

Discussion was held on how much time was put into the program.

The Public Hearing was opened.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

ACTION: Motion was made by Vice Chairperson Fort and seconded by Commissioner Garcia to adopt **Resolution PC No. 2019-035**, a resolution forwarding a recommendation to the City Council to: 1) Find that there will be no significant environmental impacts caused by this project, adopt an Initial Study/Negative Declaration pursuant to Section 15070 of the California Environmental Quality Act, and direct staff to file a Notice of Determination; 2) Find that the information and proposed projects identified in the 2019/2020-2025/2026 CIP are in conformance with the goals and policies of the General Plan 2015-2035; and, 3) Recommend that the City Council adopt the Preliminary 2019/2020-2025/2026 CIP. Motion passed by a vote of 3-0. (AYES: Quiroga, Fort, Garcia; NOES: None; ABSTAIN: None)

A recess was called at 6:19 p.m.

The meeting was recalled to order at 6:26 p.m.

B. Master Case No. 18-096; Tentative Parcel Map No. 20010; Tentative Tract Map No. 20224; Conditional Use Permit No. 18-027; and Design Review No. 18-028 - Monterado 253 Attached and Dettached Condominiums.

Senior Planner Paul Gonzales provided the staff report.

Staff provided a correction to Condition No. 67.

Staff addressed issues identified in the letter received from North Fontana Investment Company, LLC.

Staff addressed a letter that was submitted by the Gas Company.

Ruben Salas spoke on the water quality.

Director AbuBakar shared that the water quality report is available for review.

Discussion was held on the number of entry points for vehicles and pedestrians.

Discussion was held on the number of required parking spaces and the number of spaces provided.

The Public Hearing was opened.

Speaking for the applicant, Bryan F. Avilla spoke on meeting with stakeholders a year ago with no concerns. Mr. Avilla spoke on the vehicle and pedestrian access points and meeting parking requirements.

Applicant has read, understood and agreed to the conditions of approval.

Discussion was held on potential retailers and when they would come in.

Speaking for the applicant, Denise Ashton spoke on the concept of one grand entrance; the points of access for vehicles and emergency vehicles; the landscaping; the recreation area and the project amenities.

Discussion was held on the monitoring of vehicle parking per individual homes.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

Discussion was held on the proposed commercial area being brought back for review by the Planning Commission.

ACTION: Motion was made by Commissioner Garcia and seconded by Vice Chairperson Fort to adopt **Resolution PC No. 2019-036**, forwarding a recommendation to the City Council to: 1) Adopt the Mitigated Negative Declaration, Mitigation Monitoring Program and direct staff to file a Notice of Determination; 2) Approve Parcel Map No. 20010; 3) Approve Tentative Tract Map No. 20224; 4) Approve Conditional Use Permit No. 18-027; and, 5) Approve Design Review No. 18-028 with correction to Condition No. 67 and the addition of a condition for the commercial plan to be brought back before the Planning Commission. Motion passed by a vote of 3-0. (AYES: Quiroga, Fort, Garcia; NOES: None; ABSTAIN: None)

C. Master Case No. 15-003; Zoning Code Amendment No. 18-004 - Amendment to the zoning designations for properties within the General Plan Land Use Designation Walkable Mixed Use 1 (WMXU1) and Walkable Mixed Use 2 (WMXU2) and proposed Zoning Code Amendment to add Article 15 to Chapter 30 of the City of Fontana Municipal Code. Article 15 will include development standards to the Walkable Mixed Use-1 (WMXU1) and Walkable Mixed Use-2 (WMXU2).

Assistant Planner Cecily Session-Goins provided the staff report.

Discussion was held on color palette guidance for the project.

Senior Planner Dawn Rowe spoke on an Administrative Site Plan being required for changes to the look of the existing building, including getting new colors approved.

Discussion was held on a lighting code and signage for retail establishments.

Discussion was held on building size and addressing maximum heights.

The Public Hearing was opened.

No member of the audience spoke in favor or opposition.

The Public Hearing was closed.

ACTION: Motion was made by Commissioner Garcia and seconded by Vice Chairperson Fort to adopt **Resolution PC No. 2019-037**, and forward a recommendation to the City Council to: 1) Determine that the project has been reviewed under a previous Final Environmental Impact Report (State Clearinghouse No. 2016021099), pursuant to Section 15177(a) of the California Environmental Quality Act (CEQA) Guidelines and Section 8.10 of the City of Fontana's 2019 local CEQA Guidelines and direct staff to file the Notice of Determination; and, 2) Amend the zoning designations for properties within the General Plan Land Use Designation Walkable Mixed Use I (WMXU1) and Walkable Mixed Use II (WMXU2) and proposed Zoning Code Amendment to add Article 15 to Chapter 30 of the City of Fontana Municipal Code. Article 15 will include development standards to the Walkable Mixed Use-1 (WMXU1) and Walkable Mixed Use-2 (WMXU2). Motion passed by a vote of 3-0. (AYES: Quiroga, Fort, Garcia; NOES: None; ABSTAIN: None)

Chairperson Quiroga thanked his students for the honor and privilege of being their teacher.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of your DocuSign account. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use your DocuSign Express user account to receive required notices and consents electronically from us or to sign electronically documents from us.
