Commissioner Thrasher thanked Planning and Information Technology departments staff for their hard work and support of the commission.

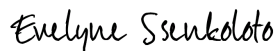

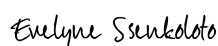

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
