**CALL TO ORDER/ROLL CALL:**

**A. Call to Order/Roll Call:**

A regular meeting of the City of Fontana Planning Commission was held on Tuesday, March 7, 2023. Chair Fort called the meeting to order at 6:02 p.m.

Following the Invocation by Chair Fort, the Pledge of Allegiance was led by Secretary Sanchez.

**A. Special Presentation:**

Recognition and Swearing-In Ceremony of Newly Appointed Commissioners for a two-

year term. Mayor Acquanetta Warren swore in Commissioners, Cathline Fort, Raj Sangha, Idilio Sanchez, Ralph Thrasher and Ricardo Quintana.

**CONSENT CALENDAR:**

**A. Approval of Minutes:**

Approve the Regular Planning Commission Meeting Minutes of February 21, 2023.

**ACTION: A Motion was made by Secretary Sanchez and seconded by Vice Chair Sangha and passed by a vote of 4-1 to approve the Consent Calendar.**

**PH-A. Master Case No. 22-061: Design Review No. 22-032 - Request for site and architectural review of an approximately 96,002 square foot industrial commerce center building on approximately 4.65 acres.**

Chair Fort opened Public Hearing

Alexia De La Torre, Assistant Planner presented the staff report.

The commission and staff discussed the view of the project from Valley Boulevard. and the commission asked for clarification on the existing wrought iron fence and the glazing on the side of the building.

Another discussion took place regarding the entry and exit points of the premises; Associate Engineer, Esmeralda Gomez commented on existing striping along Valley Boulevard and how this would allow for traffic to make left turn movements when traveling west bound on Valley Boulevard. Staff also commented on the nearest traffic signals to the project and the striped median that would allow necessary queueing along Valley Boulevard.

Additionally, the commission requested clarification on the project site map and the separate parcel along Almond Ave.

The applicant, Charlie Cisakowski on behalf of Jim Pines and Riverside/Fontana LLC stated that she read and agreed to the Conditions of Approval.

No one spoke in favor or opposition of this item.

The Public Hearing was closed.

**RECOMMENDATION:**

- 2. Approve Design Review No. 22-032.**

**PH-B. Master Case No. 22-120 and Design Review No. 22-055; A request for the site and architectural review and approval for the construction of 174 detached condominiums and two (2) parks in the Arboretum Specific Plan.**

Chair Fort opened Public Hearing.

Cecily Session-Goins, Associate Planner presented the staff report.

The Commission and staff discussed the different elevations, designs, styles, and the specifics of the Arboretum Specific Plan.

Additionally, the Commission and staff discussed the pedestrian access to the park area and the primary crossing areas. The commission inquired about different types of signage such as speed limit signs along the primary aisles of the project.

The applicant Stacey Sassaman, on behalf of North Fontana Investment Company, LLC stated that she read and agreed to the Conditions of Approval.

The commission and applicant discussed possible signage, striped crosswalk, and an addition of a speed bump to the project. The applicant agreed to a work with staff to explore different options and add a new condition of approval.

No one spoke in favor or opposition of this item.

The Public Hearing was closed.

**RECOMMENDATION:**

**Based on the information in the staff report and subject to the attached findings and conditions of approval, staff recommends that the Planning Commission adopt Resolution PC No. 2023-012; and,**

1. Determine that the project has been reviewed under a previous Final Environmental Impact Report (State Clearinghouse No. 2006071109), pursuant to Section 15162 through 15164 of the California Environmental Quality Act (CEQA) Guidelines and Section 8.10 of the City of Fontana's 2019 Local Guidelines for Implementing CEQA and direct staff to file a Notice of Determination; and,
2. Approve Design Review No. 22-055.

**PH-C Master Case No. 16-012R2, Conditional Use Permit No. 18-011R1, and Design Review No. 16-026R2 - A request to update the Narra Hills Planned Unit Development (PUD) document, revise the number of units, modify the architecture, and modify the building pad configuration that was previously approved, all for the construction of 124 units within Planning Area 4 of the Narra Hills PUD.**

Chair Fort opened Public Hearing.

Alexia De La Torre, Assistant Planner presented the staff report.

The applicant, Shannon Whittaker, on behalf of Land sea Homes, LLC stated that she read and agreed to the Conditions of Approval.

The applicant spoke regarding the redesign on the project, the change from 5 units to duplex buildings and single-family homes and why it was necessary to make the change.

No one spoke in favor or opposition of this item.

The Public Hearing was closed.

2. **Approve Conditional Use Permit No. 18-011R1 and;**
3. **Approve Design Review No. 16-026R2.**

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you.
