Mayor Warren called the meeting to order at 7:07 p.m.

City Attorney Duran reported that the City Council met in Closed Session on the items listed on the agenda and took no reportable action.

Mayor Pro Tem Garcia asked for Consent Calendar Item 'H' to be pulled for questions of staff. Deputy City Manager Phil Burum clarified comments regarding scope and timeline.

Mayor Pro Tem Garcia placed a recommendation on the floor for Consent Calendar Item 'H' as follows:

'to include building permits that were pulled as of October 1, 2022'

City Attorney Duran noted for the record that staff has provided Council with a memo on Consent Calendar Item 'H' for modifications to the Resolution presented in the staff report. Such memo was also made available to the public in the foyer.

Council Member Cothran asked a clarifying question around the reduction of 50%. Deputy City Manager Burum clarified that the 50% would be complimented to any existing agreement.

City Attorney Duran noted that the change from Mayor Pro Tem would alter Section 5 in the Resolution to read as follows, 'This program will apply to all residential permits issued between the dates of October 1, 2022, and July 31, 2023...'

Mayor Warren than identified that Section 6 would also now include the multifamily projects, as outlined in red from staff's memo.

Deputy City Manager Burum also identified the change in Section 2 from six (6) months to ten (10) months.

Council Member Sandoval asked for clarification on potential impact to the general fund going 10 months back, rather than the initial proposed 6 months. Deputy City Manager Burum provided comments.
