ADJOURNED REGULAR CITY COUNCIL MEETING

The adjourned regular meeting of the City of Fontana City Council was held on Monday, December 20, 2010, in the City of Fontana Council Chambers, 8353 Sierra Avenue, Fontana, California. Mayor Warren called the meeting to order at 6:25 p.m.

ROLL CALL:
