## TYPE OF REVIEW:

### PRELIMINARY WQMP REVIEW FOR ENTITLEMENT PURPOSES ONLY

A Preliminary Water Quality Management Plan (WQMP) consists of plans, calculations, and anything else the City's Project Engineer deems necessary to demonstrate that storm water can be effectively treated for a proposed project prior to a project's entitlement; thus, the Preliminary WQMP shall be approved in order for a proposed project to receive entitlement. Because a Preliminary WQMP is for entitlement purposes only, a new WOMP application for construction is required after the project is entitled (see below)

At a minimum, a Preliminary WQMP application submittal shall include the following:

- A WQMP Site Plan that is consistent with the Site Plan submitted for entitlement identifying:
  - ~ Areas set aside for Best Management Practices (BMPs) for water treatment;
  - ~ All proposed BMPs and their locations, sizes, and volumes;
- Required Capture and Treatment Volumes including but not limited to:
  - ~ Runoff calculations for a 2-year storm event; and,
- Any additional information, documents, or reports necessary demonstrating with certainty that the project's site plan and volume calculations for a two-year event will not be modified post-entitlement.

### FINAL WQMP FOR CONSTRUCTION

A Final WOMP for Construction is a fully completed WQMP Template with all required plans, exhibits, calculations, and reports necessary to install the project's WQMP BMPs. Approval of this WQMP is not required for project entitlement and will be reviewed concurrently with the entitlement process. Once the WQMP is "Approved for Construction," the identified BMP's can be constructed, installed, and inspected, on-site (no Memorandum of Agreement or Certification is required at this step). After completion of project construction, the installed WQMP BMP's will be Certified and recorded with a Memorandum of Agreement. Only when the MOA is recorded and Certification is completed, is the WQMP is considered "Final."

No further review is required unless the plan is "amended" (see below).

At a minimum, a Final WQMP for Construction application submittal shall include the following:

- A complete WQMP Template including all plans, exhibits, calculations, and supporting reports and documents deemed necessary to review and approve the WQMP.

### AMENDMENT TO WQMP

An Amendment is any significant change to a WQMP after it has been approved for construction or finalized. Significant changes include but are not limited to:

- Any change in the number, type, location, size, or volume of a projects originally approved BMP;
- Any changes to a project's drainage area;
- Any changes to a project's mitigation summary, operational maintenance plan, Certification, or
- Submit all required revised exhibits including a revised grading plan (separate plan check fees apply).
