

**ORDINANCE NO. 1796**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FONTANA APPROVING SPECIFIC PLAN AMENDMENT NO. 18-001, TO CHANGE THE SOUTHWEST INDUSTRIAL PARK SPECIFIC PLAN (SWIP) ZONING DISTRICT DESIGNATION FROM JURUPA NORTH RESEARCH AND DEVELOPMENT DISTRICT (JND) TO SLOVER CENTRAL MANUFACTURING DISTRICT (SCD) AT THE PROJECT SITE AND THREE (3) PARCELS DIRECTLY TO THE EAST OF THE PROJECT SITE (APN: 0237-131-25, -26 & -27).**

**THE CITY COUNCIL OF THE CITY OF FONTANA, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1.** The applicant submitted a request for Specific Plan Amendment No. 18-001, to change the Zoning District on four (4) parcels within the Southwest Industrial Park Specific Plan from Jurupa North Research and Development District (JND) to Slover Central Manufacturing District (SCD).

**Section 2.** On November 20, 2018, the Planning Commission received public testimony and evidence presented by the applicant, City staff, and other interested parties, at the Public Hearing held with respect hereto on Specific Plan Amendment No. 18-001; and

**Section 3.** On November 20, 2018, the Planning Commission approved Resolution No. PC 2018-071 and recommended approval to City Council of Specific Plan Amendment No. 18-001 and after carefully considered all information pertaining to the proposed project, including the staff report, findings, and all of the information, evidence, and testimony presented at its public hearings on November 20, 2018; and

**Section 4.** After the publication of notice as required by law, the Planning Commission and City Council of the City of Fontana, California conducted a public hearing on Specific Plan Amendment No. 18-001.

**Section 5.** Based on the information presented to the City Council at the public hearing held for Specific Plan Amendment No. 18-001, on February 26, 2019, the testimony received, and the supporting documents in evidence, the City Council found that the proposed specific plan amendment is in conformance with the goals and policies of the General Plan as referenced herein.


**Section 6.** Specific Plan Amendment No. 18-001 is consistent with the goals and policies of the City of Fontana General Plan to provide a community that is balanced between residential, commercial, and industrial that is developed to high standards and provides diverse economic and social opportunities for our citizens and those who wish to invest in the City of Fontana.

**Section 7.** Specific Plan Amendment No. 18-001 is hereby approved and the zoning district for Assessor Parcel No. **0237-122-06, 0237-131-25, -26 and -27** is changed from Jurupa North Research and Development District (JND) to Slover Central Manufacturing District (SCD), of the Southwest Industrial Park Specific Plan, as shown on Exhibit "A", attached hereto and by this reference incorporated; and

**Section 8.** This Ordinance shall take effect thirty (30) days after the date of the adoption and prior to the expiration of fifteen (15) days from the passage thereof, shall be published by the City Clerk at least once in the Herald News, a local newspaper of the general circulation, published and circulation in the City of Fontana, and henceforth and thereafter the same shall be in full force and effect.

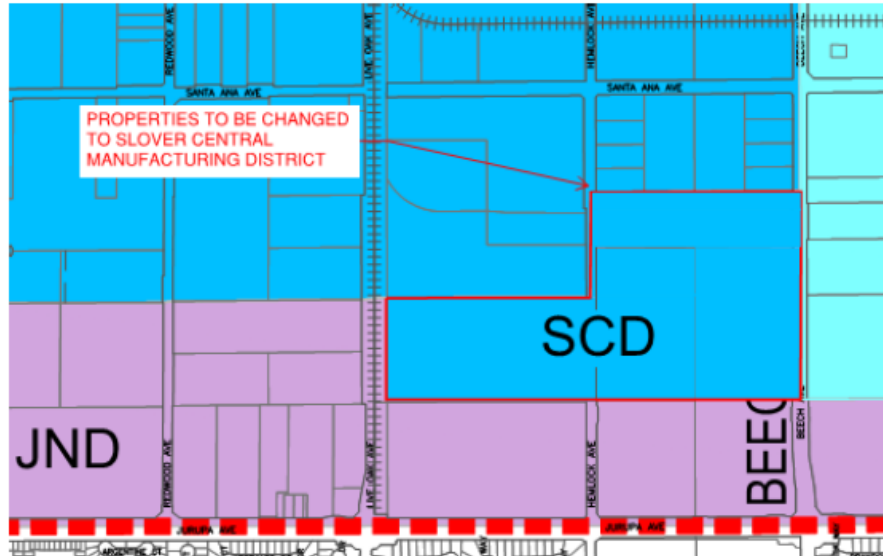

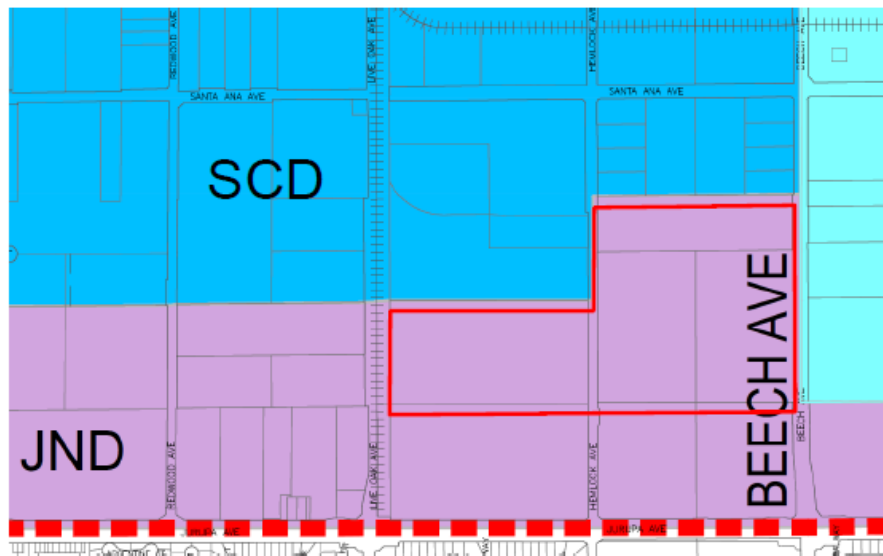
