INSURANCE REQUIREMENTS

To perform any work under contract with the City of Fontana, a Certificate of Insurance (COI), naming the City as additionally insured, must be provided. This Certificate must be on file with the City before any City contract may be approved and before you may commence any contract work. The per occurrence limit specifies that your company is covered for up to \$1,000,000 per occurrence (accident/claim) against your company, no matter how many/ The aggregate limit specifies that you are covered up to \$2,000,000 collectively for all occurrences (accidents/claims) against your company.
