**#3 TIER** – Allocation Priority 3 Resident Youth Sports Organization/Club Team (RYSO) \$15.00 Per Hour/Per Field, \$32.00 Per Hour/Per field with lights, \$10.00 Per Hour/Per field Turf fee. Qualified organizations must show & maintain 50% or greater Residency Rate per allocation period.

THE UNDERSIGNED states as follows: I, the lessee hereby for myself, my heirs, executors and administration release, discharge, and hold harmless the City of Fontana, FUSD and/or CJUSD (the Lessor), its departments, and all employees from any and all right, claim, and liability for damages for any injury and all injuries that might be sustained by me or any other persons attending or participating in the event for which the park/facility has been rented.

FURTHER, I agree that I will defend, and hold harmless the City of Fontana, FUSD and/or CJUSD against all claims, demands, and causes of actions, including courts costs and attorney's fees, directly or indirectly arising from any action or other proceeding sought by or prosecuted for in connection with the event for which the park/facility had been reserved/rented. I do acknowledge that I have read the foregoing paragraphs and know and understand the contents thereof. I further acknowledge that as the applicant I am an authorized official of the group submitting this application. I have read the Athletic Fields Policies, Ordinance 19.1 and hereby accept the responsibility of adherence to the policies by my group. I further understand that all parks and facilities are rented on an "as is" basis, and that no guarantees are made as to the availability of amenities.

The user group under permit assumes financial responsibility for all related accidents, injuries, damages, maintenance and/or repairs associated with facility use. Payment is required once permit is generated. A transaction fee of \$3.00 will be charged each time you apply a payment. All payments must be made online or in person at the Miller Fitness Center located at 17004 Arrow Blvd, Fontana, CA 92335. Office hours are Monday-Thursday 9:00 AM –1:00 PM.

User groups are responsible for all program related activity under permit basis while conducting activity city property.

Abide, adhere and enforce the Fontana Artificial Turf Sports Complex Rules:

- Players must wear standard molded cleats—Not to exceed 2 inches in length. No metal, V-cleats or street shoes allowed
- No Staking of any objects into field turf is allowed.
- Chewing gum, shelled snacks (i.e. sunflower seeds, pumpkin seeds etc.) flavored drinks, including soft drinks, sports drinks, and energy drinks are prohibited.
- Paint or field marking materials are prohibited
- No chairs, vehicles or smoking allowed on the field. Only carts with pneumatic rubber turf tires will be allowed directly on the field playing surface. Carts should be clean at all times to prevent mud or dirt from being deposited on the field surface.
- Permitted organization must designate a representative/supervisor during field use. The field supervisor is directly responsible for the City of Fontana Procedures for Artificial Turf Fields. All trash be removed from the field, surrounding areas and parking lot as needed,
