

ORDINANCE NO. 1853

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FONTANA APPROVING SPECIFIC PLAN AMENDMENT NO. 19-011 TO MODIFY THE BOUNDARIES OF THE SOUTHWEST INDUSTRIAL PARK SPECIFIC PLAN (SWIP) TO INCLUDE THE SUBJECT PARCELS AND TO DESIGNATE A SPECIFIC PLAN ZONING OF SLOVER EAST INDUSTRIAL DISTRICT (SED).

THE CITY COUNCIL OF THE CITY OF FONTANA, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The applicant submitted a request for Specific Plan Amendment No. 19-011, to expand the Southwest Industrial Park Specific Plan (SWIP) to the east to Juniper Avenue to facilitate the development of the project; and

Section 2. On October 20, 2020, the Planning Commission received public testimony and evidence presented by the applicant, City staff, and other interested parties, at the Public Hearing held with respect hereto on Specific Plan Amendment No. 19-011; and

Section 3. On October 20, 2020, the Planning Commission approved Resolution No. PC 2020-052 and recommended approval to City Council of Specific Plan Amendment No. 19-002 and after carefully considering all information pertaining to the proposed project, including the staff report, findings, and all the information, evidence, and testimony presented at its public hearing on October 20, 2020; and

Section 4. On November 10, 2020, the City Council held a duly noticed public hearing on Specific Plan Amendment No. 19-011 along with the entitlement referenced herein, received testimony, and the supporting documents in evidence, the City Council found that the Specific Plan Amendment is in conformance with the goals and policies of the General Plan to provide a community that is balanced between residential, commercial, and industrial and that is developed to high standards and provides diverse economic and social opportunities for our citizens and those who wish to invest here; and

Section 5. Based on the information contained in the Environmental Impact Report (EIR) prepared for the proposed project, an Environmental Impact Report (State Clearing House No. 2020040155) has been prepared with a recommendation to certify the EIR by the City Council; and,

Section 6. The City Council approves Specific Plan Amendment No. 19-011 to expand the SWIP boundaries just east of Juniper Avenue to facilitate development of this project as shown on "Exhibit A", attached hereto and by this reference incorporated; and,

Ordinance No. 1853

Section 7. This Ordinance shall take effect thirty (30) days after the date of the adoption and prior to the expiration of fifteen (15) days from the passage thereof, shall be published by the City Clerk at least once in the Herald News, a local newspaper of the general circulation, published and circulation in the City of Fontana, and henceforth and thereafter the same shall be in full force and effect.

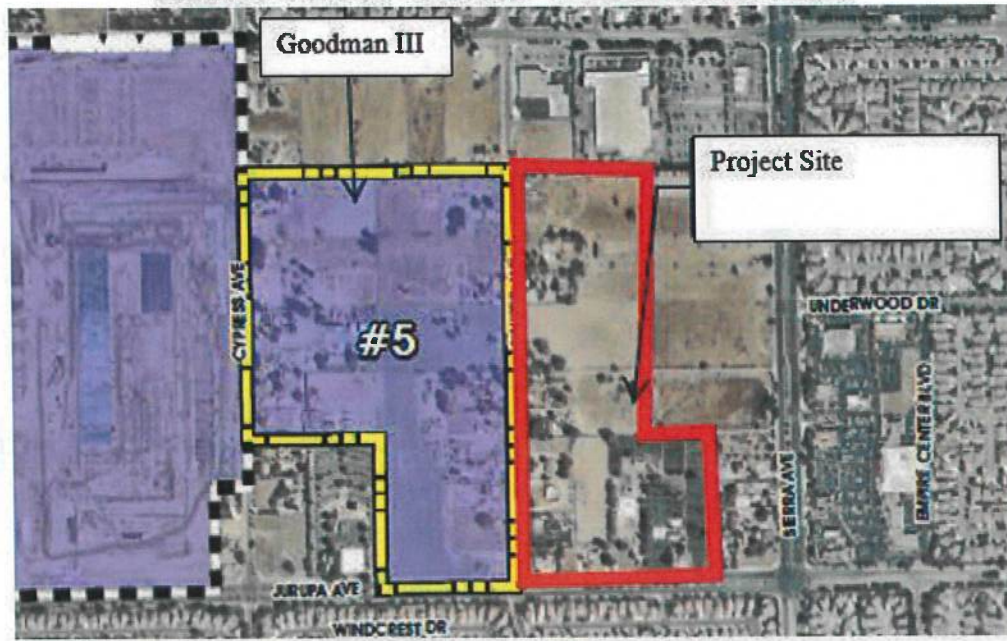

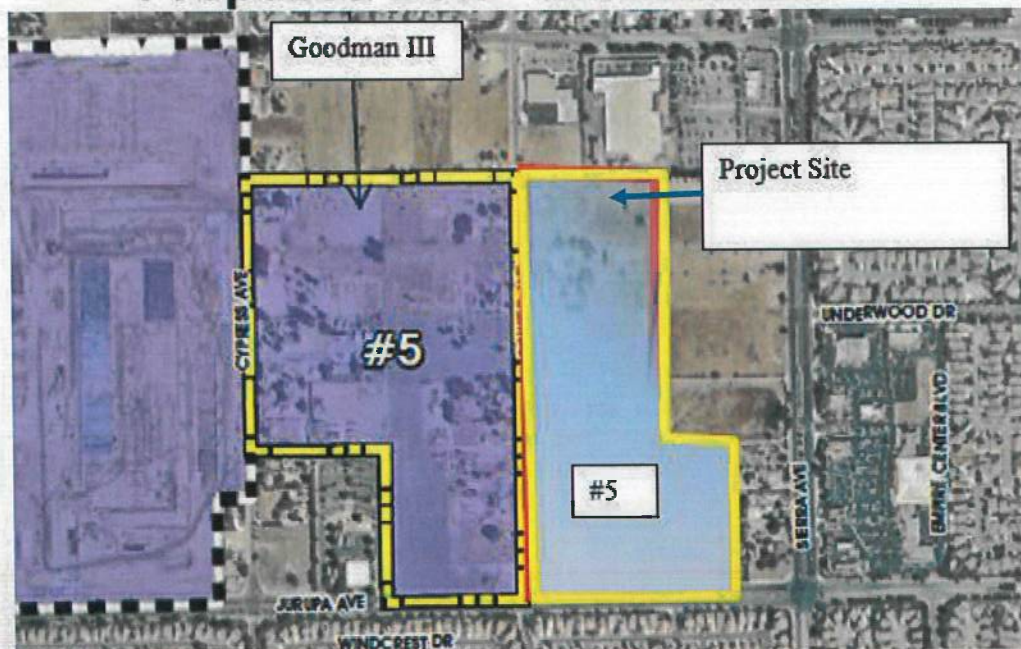

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Fontana (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us.
