This Notice shall satisfy the above-cited two separate but related procedural notification requirements.

NOTICE IS HEREBY GIVEN that on or about February 13, 2009, the City of Fontana will submit a request to the U.S. Department of Housing & Urban Development (HUD) Los Angeles Field Office for the release of Neighborhood Stabilization Program Substantial Amendment grant program (NSP), for the following program/project: City of Fontana's Neighborhood Stabilization Program, for the purchase of foreclosed homes for rehabilitation, resale and to add to the permanent affordable rental housing in the community. Eligible homes within the following designated target census tracts will be considered for the program: 002701, 002601, 002602, 002603, 002010, 002303, 002402, 002502, 002800, 002901, 002902, 003000, 003200, 003300, 003100 and 003401. The City of Fontana Housing Department is requesting the release of \$5,953,309.00.

**FINDING OF NO
SIGNIFICANT IMPACT**

NOTICE IS HEREBY GIVEN that the City of Fontana has determined that these projects will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at City of Fontana – Department of Housing and Business Development – 8353 Sierra Avenue, Fontana, California 92335, and may be examined or copied weekdays 8:00 a.m. to 5:00 p.m.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the City of Fontana – Department of Housing and Business Development – 8353 Sierra Avenue, Fontana, California 92335. All comments received by February 15, 2006 will be

considered by the City of Fontana prior to authorizing submission of a request for release of funds. **Commentors should specify which part of this Notice they are addressing.** Comments will be accepted until 5:00 p.m. on February 12, 2009.

RELEASE OF FUNDS

The City of Fontana certifies to the HUD Los Angeles Field Office that Kenneth R. Hunt in his capacity as City Manager consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Fontana to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the City of Fontana's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Fontana; (b) the City of Fontana has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures t 58, Sec. 58.76 and shall be addressed to the HUD Los Angeles Field Office at 611 W. 6th Street, Suite 800, Los Angeles, CA 90017. Potential objectors should contact the HUD Environmental Officer, HUD Los Angeles Field Office (tel 213-894-8000 or via fax 213-894-8122) to verify the actual last day of the objection period.
